* WHAT IS CONSIDERED TO BE (NON-CHARGEABLE) RESIDENTIAL WASTE?

Residential Waste is ordinary household trash and yard waste from your primary residence. Most residential waste can be disposed of **WITHOUT CHARGE** at the collection and recycling centers and landfill due to the fact that a disposal fee has already been collected through the Solid Waste Tax Levy on residential property tax bills. The resident must be present with identification. Examples of non-chargeable residential waste include: appliances, clothing, furniture, green waste, mattresses, small amounts of construction, and ordinary household trash. **Tires, refrigerators, air conditioners and/or large truckloads of concrete, land clearing, demolition and remodeling materials are subject to tipping fees.**

All waste generated from commercial customers, landscapers, contractors, subcontractors and/or rental properties must be brought to the landfill and will be subject to fees. Use of the collection and recycling centers is strictly prohibited.
