#### **Materials Accepted**

- Acids
- Brake fluid
- Bug spray
- Carburetor cleaner
- Degreasers
- Fertilizer with weed killer
- Fire extinguishers
- Furniture stripper
- Glue with solvents
- Insect killer
- Lighter fluid
- Mercury including thermometers, thermostats and debris
- Mothballs
- Paint, liquid (up to 8 gal)

- Paint related Materials (e.g. thinner)
- Pesticides, insecticides, fungicides, herbicides
- Polish with solvents
- Pool chemicals
- Roach and ant poison
- Rodent bait
- Spot remover
- Spray paint
- Stain, varnish and lacquer
- Turpentine
- Weed killer
- Wood preservatives

NO LIMITS on any items except paint as noted.

### What You Need to Know

- All household hazardous waste (HHW) drop-offs will be held from 9 a.m. to 3 p.m.
- Open to Lexington County, SC residents only. No charge. Proof of residency (e.g. driver's license or utility bill and picture ID) is required!
- No material generated by businesses is accepted (including churches, schools, rental properties, and non-profits).
- No explosives, ammunition, medical waste, pharmaceuticals, sharps/needles, or radioactive waste (which includes smoke detectors). No electronics.
- Paint is limited to 8 liquid gallons per household (oil or latery based)
- Material should be brought in boxes or plastic tubs, not bags. Containers will be returned upon request.
- Residents are asked to stay in their vehicles for safety and efficiency while hazardous waste staff unload materials onto the table under the tent near the semi-truck. Masks are strongly encouraged.
- Federal and state regulations only allow hazardous waste to be collected at permitted sites by certified hazardous waste companies.

Friday, Oct. 16 at Bush River Rd. Collection and Recycling Center (6109 Bush River Rd, Columbia, SC 29212)
Saturday, Oct. 17 at Chapin Collection and Recycling Center (103 Distant Ln, Chapin, SC 29036)
