BENEFITS FOR PURPLE HEART RECIPIENTS



Recipients of the Purple Heart are entitled to a range of benefits from the Federal government and South Carolina. Recipients are entitled to:

- Two motor vehicle license platesfree of charge
 - Special Purple Heart license plate- requires payment for personalized plate- holders of the special plate are allowed to park in parking lots or parking meters

without charge

- Free tuition for children at state-supported institutions
- Priority group 3 at VA Medical Centers- no outof-pocket payments (co-payments) for either inpatient or outpatient medical services
- Prescriptions require a \$7 co-payment for 30-day supply of prescription medications for non-service connected conditions

AGENT ORANGE

Veterans of Vietnam and Korea may be entitled to service-connected benefits if they have certain cancer conditions or diabetes. Vietnam veterans who served in the Republic of Vietnam during the period beginning January 9, 1962 to May 7, 1975 and having the designated diseases are included as are veterans who served in Korea from 1968-1969. Any diabetes or cancer condition may entitle such veterans to service-connected disability.

Veterans who need medical treatment that may be related to their exposure to Agent Orange or other herbicides should contact the Agent Orange Registry at the VA Medical Center for eligibility information and possible medical treatment.

MILITARY HONORS

Any honorably discharged veteran is entitled to receive military honors at burial. Two representatives from the military, one of which must be from the



veteran's branch of service, will be in attendance. The two representatives will fold the casket flag and present it to the

next of kin. If a bugler is not available, a recorded version of Taps will be played.

Retired veterans or certain other veterans may receive full military honors which includes a firing detail and a flag detail to fold the flag. The firing detail will fire a 21 gun salute (generally 3 salvos of 7 shots each).

The funeral home will arrange for the flag and appropriate honors.

RECORDING OF DD214s

DD214s or discharge papers filed with the Veterans Affairs Office are not a matter of public record and are not accessible to the public. Copies are available only to the veteran, next of kin, and family members.

Veterans are urged to file their copies of DD214s or discharge papers with the Veterans Affairs Office for security and accessibility.

BLUE STAR BANNERS

Blue Star Banner flag was first displayed in the front windows of homes during World War I to signify a son or husband serving in the Armed Forces. The flag quickly became known as the "son in service flag" with each blue star indicating one family member. During World War II, the Department of War issued specifications on the manufacture of the flag as well as guidelines indicating when and by whom the banner could be flown or the lapel pin could be worn.

Each blue star represents one family member serving in the military. The blue star is covered or replaced with a gold star to indicate that the family member was killed or died during the war or period of hostilities. The blue represents hope and pride, and the gold represents star sacrifice to the cause of liberty and freedom.



The lapel pin is authorized to be worn by family members of the military member which includes: wife, husband, mother, father, stepmother, stepfather, parent through adoption, foster parents, children, stepchildren, children through adoption, brothers, sisters, and half brothers and half sisters. At the current time, grandparents are not included on the official list.

The service banner may be displayed in a window of the place of residence of persons who are family members of service members serving during any period of war or hostilities. The banner may be displayed for the duration of the period of war or hostilities.

TRUSCELLO ELECTED DAV SENIOR VICE COMMANDER

At the recent DAV Department Convention, Marian J. Truscello of Batesburg-Leesville was elected Senior Vice Commander of the Department of South Carolina Disabled American Veterans. An Air Force nurse during the Korean War, she is the first woman to hold the office.

PRISONER OF WAR MEDAL

The POW Medal is authorized for any person who, while serving in any capacity with the U.S. Armed Forces, was taken prisoner and held captive after 5 April 1917. The POW Medal is to be issued only to those U.S. military personnel and other personnel granted credible U.S. military service who were taken prisoner and held captive.

- (1) While engaged in an action against an enemy of the United States.
- (2) While engaged in military operations involving conflict with an opposing foreign force.
- (3) While serving with friendly forces engaged in an armed conflict against an opposing force in which the United States is not a belligerent party.

The POW Medal may be awarded posthumously. The primary next of kin of eligible prisoners of war who die in captivity may be issued the POW Medal regardless of the length of stay in captivity.

Personnel officially classified as MIA are not eligible for award of the POW Medal. The POW Medal will only be awarded when the individual's prisoner of war status has been officially confirmed and recognized. The return of remains, in and of itself, does not constitute evidence of confirmed prisoner of war status.

All requests for the POW Medal will be initiated by eligible former POWs, or their next of kin, using a personal letter or DD form 2510 (Prisoner of War Medal Application/Information). Applications should be forwarded to the Commander, ARPERCEN, ATTN: DARP-VSE-A, 9700 Page Boulevard, St. Louis, M0 63132-5200.

- (1) instant drink/coffee mixes/cool aid in packets (sugar already added)
- (2) playing cards
- (3) travel board games
- (4) paperback books
- (5) pre-packaged crackers and cookies
- (6) individually wrapped hard candy
- (7) baby wipes
- (8) disposable razors
- (9) sunscreen
- (10) chapstick
- (11) toothbrushes
- (12) toothpaste

Items should be placed in one-gallon size Ziploc storage bags. All items will be checked before distribution. Send nothing that will melt.

We expect to collect goodies to send to the troops at the Rally on September 7. More on that in future issues.
