#### **OUTREACH PROGRAM TO START**

The Veterans Affairs Office will begin monthly visits to outlying towns beginning in November. This program will allow veterans and their family members to meet with Veterans Affairs Office staff in a setting closer to home.

The Veterans Affairs Office assists former and present members of the United States Armed Forces and their families to obtain benefits for which they are entitled. The office assists veterans with service-connected and non-service-connected claims, educational benefits, home loans, and burial benefits. The office certifies and records DD-214s and assists with correcting military records.

The Homeless Veterans Standdown will be conducted on the 7<sup>th</sup> at the Salvation Army in Columbia. The Standdown provides resources including meals, human services, clothing, counseling, and medical and mental care.

Tuesday, November 11<sup>th</sup> will see the Columbia Veterans Day Parade, one of the largest in the country. This annual event will take place at 11:00 am in downtown Columbia.

Christmas candy that does not melt



This Veterans Day is another special time to remember our POWs and MIAs.

Recently, President George W. Bush proclaimed POW/MIA Recognition Day for September 19, 2003: The sacrifice and service of America's veterans, including those who became prisoners of war or who went missing in action, have preserved freedom for America and brought freedom to millions around the world. On National POW/MIA Recognition Day, we honor the extraordinary courage of the Americans who have been prisoners of war, and we pray for those who are still missing in action and unaccounted for. This Nation also remembers the challenges and heartache endured by the families of prisoners of war and missing in action. We seek answers for the families of those who are still missing, and we will not rest until we have a full accounting.



## **DEATHS OR HOSPITALIZATION**

Keep the Veterans Affairs Office informed of any hospitalizations or deaths so the staff can visit or pay respects.

With the new patient privacy legislation, it is difficult for this office to know when a veteran or family member is hospitalized or moves into a nursing home or retirement community.



#### VIDEOTAPING VETERANS

Guy G. Wright was videotaped recently relating the story of his service in the Army during World War



II. Wright enlisted when he was 15 years old and served in the Philippines. Shortly after his 16<sup>th</sup> birthday, he was captured on Corregidor and imprisoned for 40 months.

In the videotape, Wright reveals his experiences as a soldier and a POW. Wright was also featured in an October

2 news article in the *Lexington Chronicle*.

The VA Office is looking for other volunteers to be videotaped in either private interviews or at school or civic presentations.

Each videotape will be edited with graphics added. Copies will be provided to the veteran, Library of Congress, local school, library, and to the VA office.

Funding for this project has been accomplished through donations to the Lexington Veterans Fund by various individuals and veterans organizations.

#### TWIN CITY NEWS ARTICLES

Louise Riley continues her stories of veterans from the Batesburg-Leesville area that served during World War II. Recently, articles in the *Twin City News* were published about two Navy men, Lewis Sheppard and Clyde Clark along with three Army veterans, Bud Mabus, William R. Carson, and Hazel Black

Ms. Riley spends time with each veteran asking pertinent questions and writing lengthy stories of these local veterans. Several stories have been continued in two or three issues.

# CONCURRENT RECEIPT; VA HEALTH FUNDING

As this is being written, the dual issues of concurrent receipt and adequate funding for VA medical care are still up in the air.

The issue of concurrent receipt has resulted in legislation that the Administration has agreed to support. The bill would provide for a phase in of concurrent receipt over a 10 year period beginning in 2004. This legislation is pending passage by the House and Senate.

The House proposal expands the Combat-Related Special Compensation for all veterans rated 10% to 100% who qualified under the 2002 legislation. Those veterans would receive full concurrent receipt effective January 1, 2004.

All military retirees with more than 20 years of military service who are rated 50% or higher will have full concurrent receipt phased in over a 10 year period beginning January 1, 2004.


National Guard and Reservist retirees will be treated the same as active duty retirees in both programs.

The American Legion, Veterans of Foreign Wars, Disabled American Veterans and other veterans service organizations are fighting for a law that would fund VA health care on a mandatory rather than a discretionary basis. The funding is still almost \$2 billion short of what these veterans organizations deem appropriate. The war on terror will only make this situation worse, as wounded U.S. forces in Iraq and a rising number of recently medically retired troops seek treatment at the VA.



#### WORLD WAR II MONUMENT DEDICATION

On May 29, 2004, the National World War II Memorial will be dedicated in Washington, DC to all who served during World War II. The memorial will honor all military veterans of the war, the citizens on the home front, the nation at large, and the high moral purpose and idealism that motivated the nation's call to arms. The Second World War will be the only 20th century event commemorated on the Mall's central axis.



The memorial will be dedicated on Saturday, May 29, 2004 during a series of events in Washington and throughout the country. To learn more about the dedication plans, check out www.wwiimemorial.com
