### MAC RISH

Wyman M. Rish, Lexington County Veterans Affairs Officer from July 2001 to January 2003, died December 19 after a lengthy illness.

Mac was born in Columbia and graduated from Brookland Cayce High School and the University of South Carolina. He later received a Masters degree from Ball State University. He joined the US Air Force in 1966 and retired as a pilot after 20 years with the rank of Lieutenant Colonel.

Mac was the Mayor of West Columbia for 12 years and had just been re-elected to serve another term.

Mac is survived by his wife, Katherine "Kathy" Williams Rish and a son and daughter. He was buried at Celestial Memorial Gardens.

## BLUE STAR MOTHERS COLLECT DONATIONS

The Blue Star Mothers are continuing to solicit items to be sent to military serving overseas. Popular items among the troops are DVDs, hand-held video games, books, and magazines. The Mothers have been collecting comfort items and other material since last year. Many individuals and groups have been making donations to the Blue Star Mothers. The group, however, has been funding the shipment of the large amounts of items personally or through some donations.

The Mothers have also instituted two programs, one to assist Iraqi orphans, "Operation Desert Child", and the other to help families of military personnel, "Operation Homefront." In Operation Desert Child, the group plans to adopt an Iraqi orphanage and collect clothing, bedding, and toys for the children for children in Iraq and Afghanistan.

Operation Homefront is geared to assisting families who have suffered financial setbacks while family members have been activated. The families can use retail gift certificates, grocery gift certificates, and contributions of toys, children's clothing, and tickets to children's events.

Veterans and/or widows whose finances meet VA criteria and who need the aid and assistance of another person or who is housebound may get financial help from the VA to reside in such a facility.

## VIDEOTAPE VOLUNTEERS

We need you! We're still looking for veterans to be videotaped. Generally, the videotaping takes about an hour to 1 ½ hours. The videotape will be edited and each veteran provided a personal copy.

Veterans of any period are encouraged to be videotaped to tell the story of their military experience.

## ATTENTION FORMER POWS

The VA is contacting all former POWs to make them aware of benefits affecting them. The VA has expanded its programs to cover illnesses found to be related to captivity, including cirrhosis of the liver. According to VA Secretary Anthony Principi, "New policies make it easier for former POWs to obtain compensation if they were detained for 30 days or more and develop other illnesses.

Former POWs have a special eligibility for enrollment in the VA health care system and are exempt from copayments for inpatient and outpatient visits.

Any former POWs should contact the VA or VA office to obtain information on the benefits to which they may be entitled.

## CONCURRENT RECEIPT

President Bush signed into law legislation to phase in concurrent receipt over the next 10 years. Concurrent receipt provides for service-connected disabled military retirees to receive their VA disability without offsetting their retired pay. The policy applies to retirees with a service-connected disability of 50% or higher. The payments become effective as of January 1, 2004 and will be included on retirement checks received February 1, 2004. The schedule is as follows: 100% disability, \$750 per month; 90% disability, \$500 per month; 80% disability, \$350 per month; 70% disability, \$250 per month; 60% disability, \$125 per month; and 50% disability, \$100 per month.

## BATTLES OF THE KOREAN WAR

## VETERANS TRUST FUND

The Veterans Trust Fund was created in 1995 to serve the needs of South Carolina's veterans by supporting programs, both public and private, for veterans. The Fund works to improve the lifestyle of veterans in nursing homes, assists with transportation programs at VA Medical Centers, assists veterans groups, established memorials honoring veterans, supports scholarships, and assists with homeless veterans programs.

## KOREA DEFENSE SERVICE MEDAL

A new medal, the Korea Defense Service Medal, has been approved for veterans who served in Korea on or after July 28, 1954 for thirty consecutive or for sixty non-consecutive days, or who meet the following criteria:

- Be engaged in combat during an armed engagement, regardless of the time in the area of eligibility;
- Is wounded or injured in the line of duty and requires medical evacuation from the area of eligibility;
- While participating as a regularly assigned aircrew member flying sorties into, out of, or within the area of eligibility in direct support of military operations. Each day that one or more sorties are flown in accordance with these criteria shall count as one day toward the 30 or 60 day requirement;



Personnel who serve in operations and exercises conducted in the area of eligibility are considered for the award as long as the basic time criteria are met. Due to the extensive time period for KDSM eligibility, the non-consecutive service period for eligibility remains cumulative throughout the entire period.

The medal was authorized in December 2002 but has not been available except by purchase. The Department of Defense is working on procedures for the award of the medal. Indications are that the medal will be available early this year.
