AGENT ORANGE REGISTRY

Agent Orange was a herbicide sprayed in Vietnam, Korea and elsewhere to defoliate vegetation to remove cover for enemy troops. Over the years, a number of diseases have been identified with connection to the spraying of Agent Orange. These include Non-Hodgkin's lymphoma, soft-tissue sarcoma, chloracne, Hodgkins disease, porphyria cutanea tarda, respiratory cancers, multiple myeloma, acute and subacute peripheral neuropathy, prostate cancer, diabetes mellitus, and Chronic Lymphocytic Leukemia. Other diseases are under review by the Secretary of the Veterans Administration.

The VA established the Agent Orange Registry to provide examinations for veterans who may have come into contact with Agent Orange. Veterans who served in Vietnam after January 9, 1962 or who served in Korea beginning in late 1967 and who have any of the diseases listed above should contact the Agent Orange Helpline at 1-800-749-8387, Monday through Friday from 8:00 am to 4:00 pm Central Standard Time. A 24hour automated system is available at that time before and after normal business hours.

Dorn VA Medical Center has an Agent Orange Screening Program. There currently is about a 2 month waiting period for appointments. Veterans seeking a screening should take or fax their discharge and name and address to the Agent Orange Screening Office, fax number (803) 695-6709.

SERVICE CONNECTED?

What does it mean? Any medical condition or injury that was incurred in, or aggravated by the veteran's military service. Service connection for a disability or death is established through many ways. The four most common are:

- 1. Disability or death was incurred in military service.
- 2. Aggravation of a before service disability during service.
- 3. Presumption that the disease or disability was incurred in military service.
- 4. Because of a service-connected disability, a secondary condition has occurred.

Service connection of a disease or disability is necessary before disability compensation can be paid.

No compensation is paid if the disability is a result of a veteran's own willful misconduct or abuse of alcohol or drugs.

REPLACEMENT OF AWARDS AND DECORATIONS

A World War II veteran called then came into the office a couple of months ago. He was carrying a grocery bag, which contained a number of awards he was awarded for his service. Among those medals were the Bronze Star, Purple Heart, Combat Infantryman Badge, and several service medals and service stars. He was one happy camper.

If you have misplaced, lost, or were never presented awards to which you are entitled, a DD Form 180 may be completed requesting those awards. The appropriate branch will replace those awards one time for you without charge.

The process takes approximately 6 months from the time of the request until the medals are received.

Contact the VA office for the form or for any assistance in obtaining these awards.

SIGN UP FOR MEDICAL CARE

Applications for medical care are being accepted at Dorn VA Medical Center on VA Form 10-10EZ. Veterans are enrolled into 8 categories. Due to the influx of veterans seeking medical care through the VA, the Category 8 veterans are those who do not have any service-connected disability or a 0% disability and whose income and net worth is above a local threshold and index.

Veterans should complete the application to get enrolled even though medical care may not be readily available. The form is available on-line or from the VA office.

SURVIVOR BENEFITS

President Bush signed into law the Veterans' Benefits Act of 2003. A number of changes have been made, one of which affects the surviving spouses of veterans. Under the old law, a surviving spouse who received Dependency and Indemnity Compensation (DIC) lost the benefit upon remarriage. The new law permits a surviving spouse who remarries on or after his/her 57th birthday to remain eligible for DIC, home loan and educational benefits. The effective date of the change is January 1, 2004.

Surviving spouses who remarried after reaching age 57 and who file claims for the restoration of their benefits during calendar year 2004 are entitled to benefits from January 1, 2004. However, surviving spouses who remarried after turning 57 prior to the enactment of this legislation have one year (until December 16, 2004) to apply for restoration of benefits.

Eligible surviving spouses whose claims for restoration of benefits are not received prior to December 16, 2004 are not entitled to restoration of benefits.

This also eliminates, for spouses of deceased military retirees who currently receive SBP, the SBP/DIC offset for those benefiting from these changes.
