# NATIONAL VETERANS AWARENESS WEEK

Senate Resolution 155, introduced by Sen. Joseph R. Biden, Jr. (D-Del.), designated November 6-12 as National Veterans Awareness Week. This special week is designed to serve as the focus for educating schoolchildren about the contributions and sacrifices of America's war veterans.

It also encourages veterans to enter the classroom and work with students and teachers. The resolution's introduction says the week is "to point out the need to *develop educational programs* [emphasis added] regarding the contributions of veterans to the country."

Noting the sharp decline in the number of American families that have a personal connection to the armed forces since the advent of the allvolunteer military, the resolution is clear in its intent.

A key statement reads that it is "essential that the future leaders of the nation understand the *history of military action* [emphasis added] and the contributions and sacrifices of those who conduct such actions." (*VFW*, September, 2005).

# **HELPING VETERANS FIND JOBS**

Veterans interested in obtaining job help from the federal government should familiarize themselves with VETS—the Veterans Employment and Training Service. VETS is a Labor Department agency headed by an assistant secretary and was created nearly 25 years ago with a specific mission; help veterans find jobs.

One-Stop Career Centers are located in state employment offices, but the *Jobs for Veterans Act of 2002 (Public Law* 107-288) mandates that veterans have priority of service.

# DIABETES HIGHER AMONG VIETNAM AIRMEN

A 20-year Pentagon study of U.S. airmen exposed to Agent Orange during the Vietnam War found that they have a higher risk of diabetes. Airmen who served on ground crews had the highest average traces of dioxin, which is found in the herbicide, and showed a 166% increase in diabetes requiring insulin control.

The 2002 Ranch Hand Study, named after the operation that sprayed Agent Orange to kill foliage in Vietnam between 1962-71, examined 1,951 Air Force vets who served in Vietnam. Its findings supported earlier studies in 1992 and 1997. The National Academy of Science and the VA secretary will review the study.

Other findings included an increase in the frequency of reported acne and elevated blood lipids that tended to increase with dioxin levels. However, no significant increase in the risk of cancer was found. Ranch Hand ground crews, the subgroup with the highest dioxin levels, showed a 14% decreased risk of cancer.

The Pentagon noted three limitations to the study:

- The results cannot be generalized to all Vietnam veterans.
- The size of the study makes it difficult to detect increases in rare diseases.
- Other variables that were not considered in the report could have influenced the results.

## NATIONAL GUARD AND RESERVE HOME LOAN UPDATE

Members of the Guard and Reserve usually have to serve six years before becoming eligible for a Veterans Administration (VA) home loan, but it's important for those who have been called to active duty to know that they have only a 90-day service requirement to qualify.

Members of the Guard and Reserve discharged after less than 90 days with a service-connected disability are also eligible.

Many of the recently activated Guard members and Reservists are unaware that they qualify for a VA home loan, according to VA officials.

One of the biggest advantages of a VA loan is that borrowers can finance their purchase, up to \$359,650, without making a down payment.

Reservists and Guard members do pay a slightly higher loan fee on a zero-down loan--2.75 percent, compared to 2 percent for active-duty servicemembers. Those percentages can be reduced with 5- or 10-percent down payments and the fees can be included in the loan amount.

There are some other small differences in the basic eligibility requirements between home loans for active-duty and reserve-component troops. Military.com offers a wealth of information about the VA home loan program and the VA also has more details about loan benefits and other benefits which are organized in a concise, easy-to-follow guide.

There's also a VA toll-free number, 1-888-487-1970, to call with any questions you might have.

The best way for Guard members and Reservists to find out if they qualify for a home loan is to apply for a certificate of eligibility. Some lenders will handle the application paperwork.

During peacetime, the eligibility requirement for regular active duty personnel is 181 days of continuous active duty with an honorable discharge. Eligibility is also granted to those who are discharged with a service-connected disability with less than 181 days service. Wartime active-duty servicemembers must serve 90 days or less if they have a service-connected disability.

#### NEW WEBSITE FOR WAR WIDOWS AND SURVIVORS

A new website for surviving spouses and dependents of military personnel who died while in the service of their nation has been launched by the U.S. Department of Veterans Affairs. It is located at

At a committee hearing in February, Tiffany Petty, a 25year-old mother of two from Idaho, told the committee about the difficulty she had receiving clear information about the benefits and help she and her children could receive, after her husband Jerrick was killed in <u>Iraq</u>. At the same hearing, Jennifer McCollum, a 31-year-old woman from Jacksonville, Florida, told the committee that help from the government agencies "seems to be the exception, rather than the rule." Her son was born several months after her husband was killed in a military plane crash in Pakistan.

According to calculations run by the Senate Committee on Veterans' Affairs, a surviving spouse and two children of an enlisted servicemember killed while serving in the military could receive over \$600,000 in benefits. The money would break down as follows:

#### \$1 BILLION AWARDED TO INJURED RETIREES

August 17, 2005. Military.com has learned that the \$1 billion has been awarded to retirees with disabilities across all military uniformed Services through the Combat-Related Special Compensation (CRSC) program. Enacted by Congress in 2002, CRSC is a \$22 billion program that provides tax-free monthly payments to injured retirees from all uniformed services. CRSC payments are retroactive and supplement a retiree's Veteran Affairs (VA) disability pay and Service retired pay.

COL John Sackett, Army CRSC Chief, states "This is a great milestone but we have a long way to go. Retirees with disabilities have more than earned this compensation. Billions of dollars are still available, so we hope that eligible retirees will submit their claims." Out of the \$1 billion awarded across all services to date, the Army has awarded over \$575 million.

#### **Disability Pay Programs- CRSC and CRDP**

CRSC is an application-claim based program versus the Concurrent Retirement and Disability Payments (CRDP) program, which is an automatic entitlement from DFAS for any Retiree with a combined 50% or higher VA disability rating. Some Retirees believe they are already receiving CRSC when they are actually receiving CRDP and thus do not submit their claim for CRSC. If you are not certain what you are receiving, please check your DFAS pay stub and consider submitting your claim for CRSC.

It is important to note that Retirees cannot receive both CRSC and CRDP and must elect one each year through an annual "program election."

#### Are you eligible?

Eligible claimants are/ have:

- Retired with 20 yrs Active or Reserve Duty;
- Receiving retired pay;
- Retired pay must be offset by VA payments;
- A 10%+ disability rating; and
- At least one combat-related disability.

**Combat-related criteria** include those VA rated disabilities that occurred under the following situations:

• In the performance of duty under conditions simulating war (e.g., named exercises, routine field training exercises)

• While engaged in hazardous service (e.g., flight, diving, parachute duty)

• Through an instrumentality of war (e.g. combat vehicles, weapons)

• As a direct result of armed conflict (e.g. Purple Heart) **OR** 

• Presumptive cases (e.g. Agent Orange, radiation exposure, Post Traumatic Stress Disorder)

#### EMPLOYMENT SERVICES FOR VETERANS

The U.S. Department of Labor, Veterans' Employment and Training Service (VETS) offers employment and training services to eligible veterans through a non-competitive Jobs for Veterans State Grants Program. Under this grant program, funds are allocated to State Workforce Agencies in direct proportion to the number of veterans seeking employment within their state. The grants support two principal staff positions:

- Disabled Veterans' Outreach Program Specialists (DVOP), and
- Local Veterans' Employment Representatives (LVER)

This grant provides funds to exclusively serve veterans, other eligible persons, transitioning service members, their spouses and, indirectly, employers. The grant also gives the State the flexibility to determine the most effective and efficient distribution of their staff resources based upon the distinct roles and responsibilities of the two positions.

DVOP and LVER staff provide services to all veterans that Title 38 indicates are eligible for their services, but their efforts are concentrated.

#### NEW LAW TO AFFECT SGLI PAYMENTS & PREMIUMS

Defense and Veterans Affairs officials are ironing out details of programs that will expand benefits provided through Servicemembers' Group Life Insurance.

The \$82 billion supplemental legislation signed into law by President Bush May 11<sup>th</sup> increases maximum SGLI coverage to \$400,000 and provides payouts of up to \$100,000 for service members with traumatic injuries.

The increased SGLI coverage will take effect Sept. 1, and the so-called "traumatic SGLI" benefit, Dec. 1. Legislation directs that both benefits will be retroactive to Oct. 7, 2001.

Traumatic SGLI benefits will be retroactive for troops who have lost limbs, eyesight or speech or received other traumatic injuries as a direct results of injuries received during Operations Enduring Freedom or Iraqi Freedom. The benefit does not apply to service members suffering from disease.

Troops opting for maximum SGLI coverage--\$400,000 vs. the current \$250,000—will see their monthly premiums increase from \$16.25 to \$26.00. This is based on the rate of 6.5 cents per \$1,000 of insurance coverage.

SGLI coverage is currently available in \$10,000 increments, but as of Sept. 1, the increments will increase to \$50,000.

Because the rates have not changed, service members who retain \$250,000 or less coverage will see no increase in their premiums except for the \$1 "traumatic SGLI" premium.

While these expanded benefits will be provided retroactively, affected service members won't be charged retroactive payments. DoD will absorb that cost.

In a new twist introduced through the supplemental legislation, troops with dependents must get their spouse's approval to purchase less than the full amount of SGLI coverage. In the case of single members, notice will be provided to the designated beneficiary when the member purchases less than the maximum coverage. (*Deployment Ouarterly*, Summer, 2005). #### DoD PROVIDES SEVERELY INJURED TROOPS WITH A NEW RESOURCE

Severely injured service members and their families have a new resource to help them put their lives back together after the service member's injury. Service members and their families can call the toll-free number at (888) 774-1361 for information and referrals. That phone number is the 24/7 helpline for the Military Severely Injured Joint Support Operations Center.

When a service member or family members calls the center for the first time he or she is assigned a care manager. That care manager follows the case for as long as they need assistance offering help as needed with case management, hospitalization, financial support, education and employment assistance, information on Department of Veterans Affairs benefits, family counseling, local community resources and child care support. The care managers are all registered nurses who have experience working with disability patients.

#### INCARCERATED VETERANS TRANSITION PROGRAM

The Incarcerated Veterans Transition Program (IV-TP), managed by the U.S. Department of Labor, Veterans' Employment and Training Service (VETS), is designed to help ex-offender veterans who are at risk of homelessness to re-enter the workforce. The program provides direct services—through a case management approach—to link incarcerated veterans with appropriate employment and life skills support as they transition from a correctional facility into the community.

Services provided through IV-TP may include:

- Job search activities/counseling
- Job preparatory training
- ◆ Classroom training
- Job placement and follow-up services

To be eligible, an individual must be a <u>veteran</u> and <u>within 18 months</u> of release from a participating correctional institution of facility. The term "veteran" means a person who served in the active military, naval, or air service, and who was discharged or released there from under conditions other than dishonorable.
