441.5 BILLION DEFENSE BILL INCLUDES BENEFITS CHANGES

Congressional negotiators have approved several landmark changes in military benefits, particularly for members of the National Guard and reserve.

The 2006 defense authorization bill approved Dec. 16 by House and Senate negotiators includes:

• A precedent-setting plan opening the military's Tricare health plan to any drilling member of the National Guard or reserve who agrees to continue in uniform.

• Income replacement pay of up to \$3,000 for reservists mobilized for 18 months or longer who make less money on active duty than as civilians.

• A change allowing reservists mobilized for more than 30 days to receive full Basic Allowance for Housing, which means an average increase of \$400 a month.

The compromise bill also includes extensions of more than 20 pays and bonuses that are due to expire Dec. 31; creates a \$2,500 bonus for transferring from one service to another; and increases the maximum payment possible for assignment incentive pay and hardship duty pay.

Lawmakers were putting final touches on the bill and hope to get it to President Bush for his signature by Christmas.

The \$441.5 billion defense bill, which carries an additional \$50 billion in war-related supplemental spending, includes authorization to increase active-duty strength by 10,000 soldiers and 1,000 Marines as part of a package of personnel-related provisions aimed at reducing the burden of deployments and encouraging enlistment and re-enlistment.

Among the pay-related provisions is a decision, which would apply retroactively, to provide a \$100,000 death gratuity to survivors of all service members who die on active duty, not just those who die in combat or combat-related training. The new eligibility would be retroactive to Oct. 7, 2001, with back payments due to families who received as little as \$12,000 because last year the Pentagon proposed, and Congress endorsed, a policy that paid more for combat deaths than noncombat deaths.

For service members who incur wounds, injuries or illnesses incurred in a combat zone or in a combat operation, negotiators also agreed to create a new \$430 monthly payment that would be provided for the entire time spent recovering in a military hospital.

For military retirees who are rated 100-percent disabled by the Department of Veterans Affairs for non-combat injuries and have unemployability as a factor in their rating, the bill promises a modest change — by 2009, they will be allowed to concurrently receive their full retired pay and veterans' disability compensation. Current law would have made them wait until 2014 to receive full payment of both.

MEDICARE PRESCRIPTION DRUG PLANS (Medicare Part D)

Starting January 1, 2006, prescription drug coverage will be available to everyone with Medicare through Medicare prescription drug plans. All Medicare prescription drug plans will provide at least a standard level of coverage set by Medicare. VA has determined that its prescription drug cover-age for veterans enrolled in the VA health care program is at least as good as the standard Medicare prescription drug coverage benefit, meaning that the enrollment in VA health care provides veterans with "creditable coverage" for Medicare Part D purposes.

Veterans should remember that in addition to prescription drugs, VA's Medical Benefits Package provides a full range of health care benefits. Veterans will still be eligible to receive all current health and prescription drug benefits if they choose to enroll in a Medicare prescription drug plan. Veterans do not have to choose between VA coverage and a Medicare prescription drug plan; they may participate in either or both. However, if a veterans decides to enroll in a Medicare prescription drug plan and disenroll from VA, he or she may not be able to re-enroll later if VA is not enrolling all priority groups.

What the above article means is that if you are currently receiving your medications from the VA, you need not sign up for Medicare Part D. Your VA coverage is as good. If for some reason in the future you no longer qualify for VA coverage, you can join the Medicare Part D without a penalty.

A Recovering American Sailor or Marine c/o National Naval Medical Center 8901 Wisconsin Avenue Bethesda, MD 20889 VA/DOD Seamless Transition Program The Department of Veterans Affairs (VA) and the Department of Defense (DOD) are working as partners to meet the needs of our newest veterans—the men and women who served in Operation Enduring Freedom and Operation Iraqi Freedom—by creating a seamless transition from active duty to civilian life as a veteran.

Each VA Medical Center will have a Point of Contact (POC) to assist in the transition of care from Department of Defense (DOD). Dorn VAMC POC is Richard Rivers, 803-776-4000, ext. 7982.

Each VA Medical Center will have a Case Manager for combat veterans to coordinate care over the course of time that VHA health care is being provided. Dorm VAMC OEF/OIF Case Manager is Faela Maney, 803-776-4000, ext. 7303.

The Veterans Health Care will provide up to 2 years **free** medical and mental health care from the date of separation from active duty, for health care issuess related to active duty service. Patients can receive VA hospital care, medical services, and nursing home care for any illnesses; even if there is insufficient medical evidence to conclude that their illness was a result of their combat service.

Free care can continue beyond the two years for service connected conditions. "Service Connected" conditions are mental and medical health care issues that occurred as a result of active duty service. (Non-service connected conditions can be treated, but the veteran could not incur a co-payment).

Veterans can submit their service-connection claim with the help of Veterans Service Organizations (VSO).

Veterans also are entitled to 90 days of dental care at the VA from the date of separation from active duty, if they have not received dental care within 90 days prior to separation.

Vet Centers around the nation have established an additional staff member to provide outreach specifically to OEF/OIF veterans. Columbia Vet Center contact is Susan Toth, 765-9944.

To enroll for care at a VA facility, the veteran submits a VA Form 10-10 EZ and his/her DD214 to the Enrollment/Eligibility Office. This form is available at www.va.gov and at the Enrollment/ Eligibility Office.

Each VA Regional Office has a Point of Contact for service-connection claims inquiries. Point of contact in Columbia is Marcia Hempy, (803) 255-4164.

VIETNAM VETERANS LICENSE PLATES

South Carolina Motor Vehicle special interest plates for Vietnam Veterans are now available. Cost is \$20.00 and your present plate. Must have DD-214 or other documentation to show you were in Vietnam (i.e., you were awarded the Vietnam Service medal).

VETERANS SPECIALTY TAGS

A veteran can have two of any tag he wants and for which he qualifies (i.e., V-tag, Purple Heart, POW, etc.) (except MOH). For example, if he has 6 cars he could get 2 V-tags, 2 PH tags, and 2 POW tags, BUT HE CAN ONLY RECEIVE TAX EXEMPTION ON TWO vehicles regardless of any combination of tags.

PENSION RATES AND MAXIMUM INCOME LIMITATIONS 12/1/2005 THROUGH 11/30/2006 (Pub. L 109-111)

Effective December 1, 2005, the Director, Compensation and Pension Service of the Department of Veterans Affairs', Veterans Benefits Administration issued the following draft Pension, Dependency & Indemnity Compensation (DIC) rates and income limitations. These rates will implement VA benefits increases in pension under: Pub. L 95-588 (improved Pension), the maximum annual income limitations in pension programs in effect June 30, 1960 (Old Law Pension) and the maximum annual income limitations in effect December 31, 1978 (Section 306). The new rates will be effective December 1, 2005 and will be reflected in checks or electronic transfers received by veterans and beneficiaries on or about December 31, 2005.

CLOTHING ALLOWANCE FOR CERTAIN DISABLED VETERANS
