# DATES TO REMEMBER

July 2 **Advisory Committee Meeting** Veterans Affairs Office--7:00 p.m. County Offices Closed / July 4 **Independence Day** 

Independence Day, or the Fourth of July, commemorates the formal adoption of the Declaration of Independence by the Continental Congress on July 4, 1776, in Philadelphia, Pennsylvania. The Declaration, written by a committee headed by Thomas Jefferson, is an eloquent statement of the American colonies' intention to become an independent nation. It broke the formal ties between the colonies and Britain after the American Revolution had begun. The Independence Day celebration is a reminder of the ideals on which the nation was founded.

Although the signing of the Declaration was not completed until August 1776, the Fourth of July holiday has been accepted as the official anniversary of U.S. independence. It was not declared a legal holiday until 1941, however. Today it is celebrated in all states and territories of the United States.

The first celebration took place in Philadelphia on July 8, 1776, four days after the Declaration of Independence was adopted. On that day the declaration was read aloud, city bells rang, and bands played. Within a few years the Fourth of July was observed throughout most of the new nation, although until 1783 the city of Massachusetts, Boston, commemorated Independence Day on March 5, the date of the Boston Massacre. An elaborate Fourth of July celebration was held in Philadelphia in 1788, following the ratification of the Constitution of the United States.

Several important U.S. projects were started on Independence Day. Work on the Erie Canal in

New York state began on July 4, 1817. Construction of the first railroad in the United States, the Baltimore and Ohio, was started on July 4, 1828. July 4 was the date selected in 1848 for laying the cornerstone of the Washington Monument in the U.S. capital.

# VA VET CENTERS Vital Services to Be More Accessible For Returning Veterans

The Department of Veterans Affairs (VA) vet center program, which provides readjustment counseling and outreach services to combat veterans, is expanding into 23 new communities across the nation in the next two years. These facilities are an important resource for veterans returning from the Global War on Terror and their families.

All vet centers are community-based. They provide counseling on mental health and employment, plus services on family issues, education, bereavement and outreach, to combat veterans and their families. They are staffed by small teams of counselors, outreach specialists and other specialists, many of whom are combat veterans themselves.

The vet center program was established by Congress in 1979 in recognition that a significant number of Vietnam veterans were still experiencing readjustment problems. Today, all veterans who served in combat are eligible for care at a VA vet center at no cost, as are their families for militaryrelated issues. Also eligible are veterans who were sexually assaulted or harassed while on active duty and the families of service members who die on active duty. (*What Every Veteran Should Know*, March 2007)

### **BILL RENEWED**

Most VA disability claims filed by military retirees are resolved in less than a year. But lost paperwork, administrative errors, and appeals of rejected claims delay thousands of disability awards for years on end.

The VA disability award is retroactive to the date of the application -- making some portion of past military retired pay tax-free. But to get a refund of back taxes paid, disabled retirees must file an amended tax return for each applicable year.

That's when retirees run into a major problem: the IRS Code bars filing amended returns beyond the last three tax years. As a result, VA administrative glitches and insensitive tax laws cost these disabled veterans thousands of dollars through no fault of their own.

The "*Disabled Veterans Tax Fairness Act of 2007*" (S. 326) would allow disabled veterans whose disability claims have been pending for more than 3 years to received refunds on previous taxes paid for up to five years - the length of time the IRS keeps these records.

House Champion Representative Sam Farr (D-CA)is expected to re-introduce a similar measure soon. The Farr bill would authorize a 15-year look-back exception to IRS rules for amended returns from disabled military retirees. Just back from Iraq or Afghanistan? Looking for job opportunities? # **Nursing Home Checklist**

It is important for you and your family members to visit the nursing home to make sure that it meets your needs, as well as those of your family. A few things to consider when choosing a nursing home are listed here.

Also, ask to see the nursing home's last annual state inspection report. Did the report find any problems? Ask how the problems were fixed.

# NURSING HOME RESIDENTS RIGHTS

Residents' rights are guaranteed by the federal 1987 Nursing Home Reform Law and the S.C. Code Ann. § 44-81-20. These laws require that long-term care facilities "promote and protect the rights of each resident" and place a strong emphasis on individual dignity and self-determination. A person living in a long-term care facility maintains the same rights as an individual living in the community.

All facilities are required to provide services and activities to attain or maintain the highest practicable physical, mental and psychosocial well-being of each resident in accordance with a written plan of care. The facility must give each resident or resident's representative a written plan of care. The facility must give each resident or resident's representative a written and oral explanation of the rights, grievance procedures and enforcement provisions before or at the time of admission. The resident or resident's representative's written acknowledgement of receipt of these explanations must be made a part of the resident's file.

A Resident's Rights Poster must be posted in prominent locations in all facilities. As a resident of a long-term care facility, you have the following rights:

# The right to be fully informed of

- available services and the charges for each service;
- facility rules and regulations, including a written copy of resident rights;
- address and telephone number of the State Ombudsman and state survey agency;
- state survey reports and the nursing home's plan of correction;
- advance plans of a change in rooms or roommates;
- assistance if a sensory impairment exists; and

• residents have a right to receive information in a language they understand (Spanish, Braille, etc.).

# **Right to complain**

- Present grievances to staff or any person, without fear of reprisal and with prompt efforts by the facility to resolve those grievances;
- to complain to the ombudsman program; and
- to file a complaint with the state survey and certification agency.

# Right to participate in one's own care

- Receive adequate and appropriate care;
- be informed of all changes in medical condition;
- participate in their own assessment, care, planning, treatment and discharge
- refuse medication and treatment;
- refuse chemical and physical restraints;
- review one's medical record; and
- be free from charge for services covered by Medicaid or Medicare.

# Right to privacy and confidentiality

- Private and unrestricted communication with any person of their choice;
- during treatment and care of one's personal needs; and
- with regard to medical, personal or financial affairs.

## **Homeless Veterans' Reintegration Program**

The purpose of the Homeless Veterans' Reintegration Program (HVRP) is to provide services to assist in reintegrating homeless veterans into meaningful employment within the labor force and to stimulate the development of effective service delivery systems that will address the complex problems facing homeless veterans.

HVRP was initially authorized under Section 738 of the Stewart B. McKinney Homeless Assistance Act in July 1987. It is currently authorized under Title 38 U.S.C. Section 2021, as added by Section 5 of Public Law 107-95, the Homeless Veterans Comprehensive Assistance Act of 2001. Funds are awarded on a competitive basis to eligible applicants such as: State and local Workforce Investment Boards, public agencies, forprofit/commercial entities, and non-profit organizations, including faith based and community based organizations.

Grantees provide an array of services utilizing a case management approach that directly assists homeless veterans as well as provide critical linkages for a variety of supportive services available in their local communities. The program is "employment focused" and veterans receive the employment and training services they need in order to re-enter the labor force. Job placement, training, job development, career counseling, resume preparation, are among the services that are provided. Supportive services such as clothing, provision of or referral to temporary, transitional, and permanent housing, referral to medical and substance abuse treatment, and transportation assistance are also provided to meet the needs of this target group.

Since its inception, HVRP has featured an outreach component using veterans who themselves have experienced homelessness. In recent years,

this successful technique was modified to allow the programs to utilize formerly homeless veterans in various other positions where there is direct client contact such as counseling, peer coaching, intake, and follow-up services.

The emphasis on helping homeless veterans get and retain jobs is enhanced through many linkages and coordination with various veterans' services programs and organizations such as the Disabled Veterans' Outreach Program and Local Veterans' Employment Representatives stationed in the local employment service offices of the State Workforce Agencies, Workforce Investment Boards, One-Stop Centers, Veterans' Workforce Investment Program, the American Legion, Disabled American Veterans, Veterans of Foreign Wars, and the Departments of Veterans' Affairs, Housing and Urban Development, and Health and Human Services.

# PTSD

Post Traumatic Stress Disorder (PTSD), once called combat fatigue, is an anxiety disorder resulting from exposure to a frightening event or experience. The events that cause PTSD are called stressors. They include:

- Natural disasters (floods, earthquakes)
- Accidents (car or airplane crashes, large fires)
- Man-made disasters (bombings, death camps)
- Military combat
- Violent personal assault (torture, rape)
- Being kidnapped or taken hostage
- Having suffered abuse as a child.

Symptoms include: recurrent thoughts of a traumatic event; being easily startled; unable to sleep; easily irritated, angry outbursts, or anxiety; feelings of loneliness; and problems keeping a job.

# Joshua L. Torrence Memorial Field House

# Joshua Louis Torrence July 26, 1984 - March 14, 2005

Joshua Torrence was born in Wooster, Ohio. He and his family moved to Lexington, SC in 1992. As a boy, he learned tearwork through athletics. When White Knoll High School opened in August 2000, Josh played offensive tackle on the school's first JV football team. He also participated in track and field, setting some of the school's earliest records. Josh continued to improve his athletic skills, and by his senior year, his abilities and size made him an excellent varsity lineman.

Upon graduation from WKHS, Joshua joined another team, the United States Marine Corps. In April 2004, Josh graduated recruit training at Parris Island and traveled to Camp Pendleton, CA, where he was assigned to an amphibious assault vehicle unit. In September 2004, Josh was shipped to Al-Asad, Iraq for duty in the War on Terror. Shorthy after arrival, Joshua and his crew members were transferred to Fallujah, where he served as a Lance Corporal with the 2nd Amphibian Assault Battalion, 2nd Marine Division. During his tour in Fallujah, Josh was killed while on patrol.

Joshua died doing what he loved doing best, being part of a team and serving his country. In memory of his sacrifice, White Knoll High School plans to name its new field house in his honor. We hope you will join our efforts in making this possible.

"Over the past seven years, White Knoll High School has come to be recognized as a distinctive landmark for the community it serves. We are now poised to expand that landmark to include our own football stadium and field house. We feel it is only appropriate at this time to dedicate the field house to the memory of a young man who was part of the first student body to enter White Knoll High School and part of the first football team to represent the school on the field of competition. He went on to represent his school, community, and his country in giving his life in battle in Iraq. It is with the deepest gratitude to Josh that we ask you to join us in our efforts to raise the necessary funds for the naming of the Joshua L. Torrence Memorial Field House."
