VA To Offer Health Care to 265,000 Previously Ineligible Veterans

WASHINGTON – The Department of Veterans Affairs (VA) announced today plans to re-open enrollment in its health care system by July 2009 to about 265,000 veterans whose incomes exceed current limits.

"We're pleased to be able to offer what has been called 'the best care anywhere' to many more new veterans," said Dr. James B. Peake, Secretary of Veterans Affairs. "We'll be able to provide these newly enrolled veterans with the kind of timely, high quality health care veterans who already use our system are accustomed to."

The change affects veterans whose incomes exceed the current VA means test and geographic means test income thresholds by 10 percent or less. Congress provided funds in VA's fiscal year 2009 budget to support the new enrollment.

In 1996, Congress established a priority-based enrollment system for VA and a uniform package of medical benefits for all enrollees. The legislation opened enrollment in VA's health care system to all eligible veterans and required that each year the Secretary of Veterans Affairs assess veterans' demand for services and determine if the necessary resources are available to provide timely, quality care to all enrollees.

Enrollment for the lowest priority of the eight groups—veterans who are not being compensated for a military-related disability and who have incomes above a set threshold—was suspended on January 18, 2003, although veterans in that priority group who were already enrolled for care were permitted to remain enrolled.

VA originally suspended enrollment for Priority 8 veterans because it was unable to provide all enrolled veterans with timely access to its health care due to a tremendous growth in the number of veterans then seeking enrollment.

VA now plans to reopen enrollment for a portion of these veterans without compromising the Department's ability to provide high quality health care services to all enrolled veterans who are eligible for care.

VA's computer systems are being modified to accommodate the changes, and the Department is preparing communication and education materials to ensure that Congress, veterans service organizations, and the public are aware of the coming changes.

"The rule will take effect by June 30, 2009, if the regulatory process proceeds smoothly," Peake said. "We look forward to welcoming these newly eligible veterans into the VA system. VA will continue to monitor wait times to ensure the quality of care is not adversely affected."

VA CHANGES GLOBAL WAR ON TERROR CLAIMS PRIORITY

In 2007, the Department of Veterans Affairs (VA) made the decision to grant priority status to claims processing for veterans of the Global War on Terror (GWOT). The decision was based on the fact that GWOT veterans were in the process of transitioning from the service, while veterans from other periods of war had already completed their transition.

Since that time, many GWOT veterans have benefited from this prioritization. Most of these veterans have completed their transition. Like veterans from other periods, some are now reopening their claims to request an increase in benefits. Currently both original and supplemental claims are handled on a priority basis.

In an effort to be consistent with the original reasoning for establishing a priority, the VA is adjusting its prioritization criteria. Accordingly, all claims received on or after February 2, 2009, the following criteria will apply to establish GWOT prioritization for compensation and pension claims and appeals:

- A claim from a GWOT veteran within six months of separation
- A supplemental claim from a GWOT veteran for PTSD where PTSD is not already service-connected.
- An appeal from a GWOT veteran of his/her initial claim following GWOT service.

There will be **no change** to the way GWOT claims for very seriously injured (VSI) and seriously injured (SI) GWOT veterans are processed. Also, no changes are being made to GWOT prioritization in any other Veterans Benefits Administration (VBA) programs.



CAMP LEJEUNE HISTORIC DRINKING WATER OUTREACH

Did you live or work at Marine Corps Base Camp Lejeune in 1987 or before? If so, please register with the Marine Corps by visiting the website www.marines.mil/clsurvey or by calling the Camp Lejeune Historic Drinking Water Call Center at **877-261-9782**, Monday through Friday, 8:30 a.m. to 5 p.m. EST.

In the early 1980's two solvents, trichloroethylene (TCE) and perchloroethylene (PCE), both unregulated at the time, were found in two water systems serving the Tarawa Terrace and Hadnot Point areas. Certain drinking water wells were identified as the source of the chemicals and were taken out of service in 1984 and 1985.

The Department of the Navy is funding two independent research initiatives. The Agency for Toxic Substance and Disease Registry (ATSDR) is determining if there is an association between exposure to the water and certain adverse health effects. The National Academy of Sciences (NAS) is evaluating specific health risks associated with exposure.



Upon completion of the research, the Marine Corps will directly notify those on the registry through direct mail and email.

Camp Lejeune water meets or exceeds all environmental standards today. Drinking water wells at Camp Lejeune are tested four times a year for volatile organic compounds (VOCs), in addition to monthly drinking water sampling. The base is in compliance with all federal and state laws and regulations to ensure safe drinking water.

RE-ENACTORS MARK SHERMAN'S ATTACK ON COLUMBIA

The cannons were great. But for 4-year-old Tony Pack, the best part of Saturday morning's Civil War re-enactment came when a soldier offered to let him hold his saber. "Wow," Tony breathed. "I love seeing the period dress," said the boy's mother, Katie Hardee, catching sight of two young women in hoop skirts and mink. "It just comes alive that way."

The mother and son were among 150 people who gathered on the west bank of the Congaree River early Saturday to watch as "Union troops" fired on Columbia.

Starting at 8:45 a.m., three cannons set off car alarms at the riverfront park, sent birds on the wing and shook residents of the New Brookland neighborhood from their slumber. "I called dispatch about 30 minutes before it started and said, 'Better get ready for the calls to come in,'" said West Columbia police officer Brandon Field.



The day's events included bus tours of historic sites and buildings; demonstrations and appraisals of Civil War-era artifacts; and lectures by historians, concluding with a "grand ball" at the State Museum. It's the fifth year the Greater Columbia Civil War Alliance has arranged the event, commemorating Sherman's attack on Columbia in February 1865. Organizers say it has tourist potential.

For Jerry and Kay Platt, who just moved to Columbia, it was a lesson in local history. "I'm a military buff," Jerry Platt said, "and the authenticity is just great." Mike McMillan used last year's event to explore history with his grandson, Blake Henderson. The two got a book on the Civil War and made a trip to the State House to see the stars marking cannon strikes.

Anticipating another round of fire, 9-year-old Blake pressed his hands over his ears. His grandfather grinned as the shots echoed off buildings downtown. "Awesome," he said. "Don't you know it's rattling some cages over that way if they don't know what's going on."

At the edge of a semicircle of spectators in jeans and sweatshirts stood Ciara Lee of Florence and Yvonne Brunson of Lexington, both 22. They each got up before daylight to dress in four layers of costuming, from steel corsets to rustling taffeta. This time of year, the two said, they might meet up every weekend to portray Southern belles in re-enactments. They like the role. "You feel like you're a totally different person," Lee said. "Part of something," Brunson added.



West Columbia Mayor Bobby Horton was pleased at the chance to recognize the history "right here in this spot." "I'm very encouraged by the number of young people here today," he added. "Kids read about this stuff, but they can come down and actually relive it."

The whole thing -- with 10 rounds of fire -- lasted less than 20 minutes. But half the fun was talking to re-enactors afterward, looking up-close at the costumes and weaponry. As the crowd thinned out, a group of boys picked up sticks from under a sycamore tree, battling one another with make-believe swords.

SUPREME COURT WILL NOT HEAR HAAS CASE

Background:

On August 16, 2006, the United States Court of Appeals for Veterans Claims (CAVC) held in *Haas v. Nicholson* (now *Haas v. Peake*) that Vietnam veterans who served in the waters off Vietnam (“Blue Water” Navy veterans) are entitled to disability benefits for diseases related to exposure to Agent Orange.

The Department of Veterans Affairs (VA) subsequently appealed the CAVC’s decision to the United States Court of Appeals for the Federal Circuit. On May 8, 2008, the Federal Circuit issued a decision reversing the decision of the CAVC in *Haas v. Peake*.

On June 23, 2008, the attorneys for Mr. Haas, the National Veterans Legal Services



Program (NVLSP), filed a Combined Petition on the matter. Then, on June 30, 2008, The American Legion, the Military Order of the Purple Heart, and United Spinal Association filed a brief in support of Mr. Haas’ petition. VA filed its opposition to the petition on September 12, 2008, and on October 9, 2008, the Federal Circuit denied the petition.

Final Disposition of Haas:

On October 17, 2008, Mr. Haas’ attorneys filed a Petition for a Writ of Certiorari in the U.S. Supreme Court asking the Court to overturn the Federal Court’s decision in *Haas* that denied Agent Orange-related VA benefits to Blue Water Vietnam veterans. The American Legion and other organizations filed a brief in support of that petition.

On January 21, 2009, the Supreme Court denied the petition for Writ of Certiorari, ending any further legal challenges in the matter of *Haas v. Peake*. The VA is now free to adjudicate Haas-related claims in accordance with the May 2008 Federal Circuit Court decision.

Veterans Benefits in the American Recovery and Reinvestment Act of 2009

Background: H.R. 1, signed into law on February 17, 2009 by President Obama, contains several items that are of particular import to veterans. Although one of the portions of the Act addresses offshore veterans in the Philippines, relief is also included for disabled veterans at home, as well as others.

Disabled Veterans and those receiving pensions:

Veterans in receipt of service-connected compensation or non service-connected pension, as well as survivors in receipt of Dependency and Indemnity Compensation (DIC), will receive a **one-time** stimulus payment of \$250.

The legislation orders the Secretary of the Treasury to disburse these funds to each individual who meets the criteria as set forth in the legislation.

- ◇ **Veterans in receipt of compensation and pension benefits during any of the months of Nov. 2008—Jan. 2009** are eligible for this benefit.
- ◇ The specific regulation and timeline for receipt of these funds is yet to be written.
- ◇ Those receiving Social Security benefits as well as VA benefits need to be aware that only **one \$250 check will be received** in connection to this legislation.
