State of South Caroling Governor's Proclamation

NOW, THEREFORE, I, Nikki R. Haley, Governor of the Great State of South Carolina, do hereby proclaim November 11, 2014, as





VA HEALTH CARE BENEFITS



BASIC ELIGIBILITY:

A person who served in the active military, naval or air service and who was discharged or released under conditions other than dishonorable may qualify for VA benefits. Reservist and National Guard members may also qualify for VA health care benefits if they were called to active duty (other than for training only) by a Federal order and completed the full period for which they were called or ordered to active duty.

MINIMUM DUTY REQUIREMENTS:

Veterans who enlisted after September 7, 1980, or who entered active duty after October 16, 1981, must have served 24 continuous months or the full period for which they were called to active duty in order to be eligible. This minimum duty requirement may not apply to Veterans discharged for hardship, early out or a disability incurred or aggravated in the line of duty.

ENROLLMENT:

For most Veterans, entry into the VA health care system begins by applying for enrollment. To apply, complete VA Form 10-10EZ, Application for Health Benefits, which may be obtained from our office, any VA health care facility or regional benefits office, on line at www.1010ez.med.va.gov/sec/vha/1010ez or by calling 1-877-222-VETS (8387). Once enrolled, Veterans can receive health care at VA health care facilities anywhere in the country.



PRIORITY GROUPS:

During enrollment, each Veteran is assigned to a priority group. VA uses priority groups to balance demand for VA health care enrollment with resources. Changes in available resources may reduce the number of priority groups VA can enroll. If this occurs, VA will publicize the changes and notify affected enrollees.

GROUP 1: Veterans with service-connected disabilities rated 50 percent or more and Veterans determined by VA to be unemployable due to service-connected conditions.

GROUP 2: Veterans with service-connected disabilities rated 30 to 40 percent.

GROUP 3: Veterans with service-connected disabilities rated 10 and 20 percent; Veterans who are former Prisoners of War (POW) or were awarded a Purple Heart Medal; Veterans awarded the Medal of Honor (MOH); Veterans awarded special eligibility for disabilities incurred in treatment or participation in a VA Vocational Rehabilitation program; and Veterans whose discharge was for a disability incurred or aggravated in the line of duty.

GROUP 4: Veterans receiving aid and attendance or housebound benefits and /or Veterans determined by VA to be catastrophically disabled.

GROUP 5: Veterans receiving VA pension benefits or eligible for Medicaid programs, and non service-connected Veterans and non-compensable, zero percent service-connected; Veterans whose gross annual household income and/ or net worth are below the VA national income threshold and geographically-adjusted income threshold for their resident area.

GROUP 6: Veterans of WWII; Veterans seeking care solely for certain conditions associated with exposure to ionizing radiation during atmospheric testing or during the occupation of Hiroshima and Nagasaki; for any illness associated with participation in tests conducted by the Department of



Defense (DOD) as part of Project 112/Project SHAD; Veterans with zero percent service-connected disabilities who are receiving disability compensation benefits; Veterans who served in the republic of Vietnam between 1962 and 1975; Veterans of the Persian Gulf War that served between August 2, 1990 and November 11, 1998 and Veterans who served in a theater of combat operations after November 11, 1998 as follows: 1. Veterans discharged from active duty on or after January 28, 2003, who were enrolled as of January 28, 2008 and Veterans who apply for enrollment after January 28, 2008, for 5 years post discharge 2.

Veterans discharged from active duty before January 28, 2003, who apply for enrollment after January 28, 2008, until January 27, 2011

GROUP 7: Veterans with gross household income below the geographically-adjusted income threshold (GMT) for their resident location and who agree to pay co-pays.

GROUP 8: Veterans, enrolled as of January 16, 2003, with gross household income and/or net worth above the VA national income threshold and the geographically-adjusted income threshold for their resident location and who agree to pay co-pays.

Note: Due to income relaxation rules implemented on June 15, 2009 Veterans with household income above the VA national threshold or the GHMT income threshold for their resident location by 10 percent or less, who agree to pay co-pays, are eligible for enrollment in Priority Group 8.

VETERAN HEALTH REGISTRIES

Certain Veterans can participate in a VA health registry and receive free medical examinations, including laboratory and other diagnostic tests deemed necessary by an examining clinician. VA maintains health registries to provide special health examinations and health related information.

PRESUMPTIVE SERVICE CONNECTION

What is Presumptive Service Connection?

VA presumes that specific disabilities diagnosed in certain Veterans were caused by their military service. VA does this because of the unique circumstances of their military service. If one of these conditions is diagnosed in a Veteran in one of these groups, VA presumes that the circumstances of his/her service caused the condition, and disability compensation can be awarded.

Veterans in the following groups identified below: Entitlement to disability compensation may be presumed under the circumstances described.

Veterans within one year of release from active duty: Veterans diagnosed with chronic diseases (such as arthritis, diabetes or hypertension) are encouraged to apply for disability compensation.

Veterans with continuous service of 90 days or more: Veterans diagnosed with amyotrophic lateral sclerosis (ALS) /Lou Gehrig's disease at any time after discharge or release from qualifying active service is sufficient to establish service connection for the disease, if the Veteran had active, continuous service of 90 days or more.

Former Prisoners of War---Vietnam Veterans (Exposed to Agent Orange)—Atomic Veterans (Exposed to Ionizing Radiation)—Gulf War Veterans (Undiagnosed Illness)

Veterans Crisis Line

The Veterans Crisis Line connects Veterans in crisis and their families and friends with qualified, caring Department of Veterans Affairs responders through a confidential toll-free hotline, online chat, or text. Veterans and their loved ones can call 1-800-273-8255 and Press 1, chat online, or send a text message to 838255 to receive confidential support 24 hours a day, 7 days a week, 365 days a year. Support for deaf and hard of hearing individuals is also available.



Travel Benefits for VA Healthcare

If you meet the criteria below, you may be eligible for mileage reimbursement or special mode transport in association with obtaining VA health care services.

YOU QUALIFY IF:	YOU QUALIFY FOR SPECIAL MODE TRANSPORTATION (AMBULANCE, WHEELCHAIR VAN ETC.) IF:
 you have a service-connected (SC) rating of 30 percent or more, or you are traveling for treatment of a SC condition, or you receive a VA pension, or your income does not exceed the maximum annual VA pension rate, or you are traveling for a scheduled 	 ♦ your medical condition requires an ambulance or a specially equipped van as determined by a VA clinician, and ♦ you meet one of the eligibility criteria in 1 through 4 above, and ♦ the travel is pre-authorized (authorization is not required for emergencies if a delay would be hazardous to life or health)
compensation or pension examination	

Mileage Rates

General Travel

\$0.415 (41.5 cents) per mile

Scheduled appointments qualify for round-trip mileage. Unscheduled visits may be limited to return mileage only.

Deductible

\$3.00 one-way (\$6.00 round trip)

Deductible requirement is subject to a monthly cap of \$18.00. Upon reaching \$18.00 in deductibles or 6 one-way (3 round) trips, whichever comes first, travel payments made for the balance of that particular month will be free of deductible charges.

Waiver of Deductible

A waiver of the deductible will be provided if you are eligible for travel and you:

- 1. are in receipt of a VA pension or;
- 2. are a NSC Veteran and your previous year's income does not exceed, or your projected current calendar year's income, in the year of application will not exceed the applicable VA pension rate, or
- 3. are a SC Veteran and your previous year's income does not exceed, or your projected current calendar year's income, in the year of application will not exceed the applicable national means test income threshold or,
- 4. are traveling for a scheduled compensation and pension exam

A Pilgrimage Back to Normandy "70th Anniversary of D-Day"

This is a continuation from the September/October newsletter where the Director, Ed and Mr. "Red" Smith. a local WWII Veteran from Lexington, traveled to Normandy for the 70th Anniversary along with 21 other WWII Veterans.

Day 9 – June 9, 2014

We decided we were going to all enjoy Paris for one whole day, which is our last full day in France. We began at the Eiffel Tower for a great tour of an incredible steel structure. Mr. Red opted to stay near the bus due to being tired and unable to walk very far. The tower is undergoing a complete refurbishment on the first floor and when complete, will have more modern eateries, boutiques and other shops. After this we made our way to the beautiful Seine River, which runs through town. We boarded a river boat that serves meals and had an incredible lunch with dessert and more wine. The French really do love bread and wine! The view from the boat of Paris is spectacular!



Other boats would wave at us as they passed by. The skipper made a grand announcement over the PA

system thanking our World War II Veterans. The whole boat erupted in loud cheers and applause, it was an emotional moment.

After the lunch cruise we made our way to the Notre Dame Cathedral. This has to be the most famous cathedral in the world. It is very ornate and impressive architecture. It started to rain and I opted not to stand in the long line to be admitted. Mr. Red stayed on the bus for this stop as well. As I walked in the courtyard in front of the cathedral, I heard music coming from inside. It was quite beautiful and reminded me of home. I walked around the street while looking at the people coming in and out of so many shops. Paris is a noisy but happening place littered

cannon salute for our Veterans. Many US Airways employees were standing outside to greet our plane and were holding huge US flags. This was awesome!

One of their employees came to get Mr. Red and 3 escorted him through the airport. There were more people inside who welcome us most of the way. Local Charlotte reporters were there to interview some of the Veterans. The Patriot Guard was there in full force with their flags. Mr. Red was emotional through all of this and deeply appreciated it. He was given a $\frac{2}{3}$ nice coin as we went through customs from the Border Patrol. We zipped through immigration and boarded our bus for $\frac{2}{3}$ Columbia. We were all excited and chatty all the way home. At & the SC border, the York County Sheriff's Department provided §

a police escort in the front and rear of the bus, complete with blue lights. As we entered each county on the way home, the escorts continued. Once we hit Richland County we had the biggest escort of all. We had the Sheriff, the Patriot Guard and the American Legion riders, this was really cool! They led us to our drop off point, Northeast Presbyterian Church on Polo Road.

The celebration here was loud, big and exciting. Hundreds of people showed up to welcome home our heroes and we were all in tears. There was a nice reception, hugs, high fives, back slaps and prayers. We were all thankful to God for a safe journey to Normandy and back home. We said our goodbyes and departed with our families. It was a very emotional goodbye for me and my dear friend, Mr. Red Smith. We have really bonded over these last ten days and I told him he was one of my new heroes.

As I reflect on this enormous trip, the thing I will remember the most is the relationships we

As I reflect on this enormous trip, the thing I will remember the most is the relationships we formed with one another; the bonding of the hearts. This trip was special for all of us and I have never been prouder to be an American. The people of France, Belgium, Holland and Luxemburg that we met, were all enamored by our Veterans. They were deeply appreciative for their freedom and emotional when thanking the Veterans. It was refreshing to observe the children of these people and to know their appreciation had been passed to them by their parents and grandparents. It is really sad patriotism isn't shown like this in America.

I gained twenty-two new heroes on this trip. Before I left on this trip, I called it "the trip of a lifetime" and it was exactly that. I made quite a few friends on the trip as well and am thankful for this. We agreed to keep in touch and get together again.

There is something about the Normandy region of France. It captivates you with its beauty, history and kindness. Freedom has been kind to her people and she has returned to her original beauty before war nearly destroyed the entire area. I plan to return some day and discover more of the region. Normandy has given me a new appreciation for freedom, honor and sacrifice.

The History of the Gettysburg Address

In November 1863, at the dedication of a military cemetery at Gettysburg, Pennsylvania, the site of one of the bloodiest and most decisive battles of the Civil War, President Abraham Lincoln was invited to deliver remarks, which later became known as the

Gettysburg Address. Though he was not the featured orator that day, Lincoln's 272 word address would be remembered as one of the most important speeches in American history as he brilliantly and movingly reminded a war-weary public why the Union had to fight, and win, the Civil War. In the address, he invoked the principles of human equality contained in the Declaration of Independence and connected the sacrifices of the Civil War with the desire for "a new birth of freedom," as well as the all-important preservation of the Union created in 1776 and its ideal of self-government.

The Battle of Gettysburg, fought some four months earlier, was the single bloodiest battle of the Civil War. Over the course of three days, more than 45,000 men were killed, injured, captured or went missing. The battle also proved to be the turning point of the war: General

Robert E. Lee's defeat and retreat from Gettysburg marked the last Confederate invasion of Northern territory and the beginning of the Southern army's ultimate decline.

Charged by Pennsylvania's governor, Andrew Curtin, to care for the Gettysburg dead, an attorney named David Wills bought 17 acres of pasture to turn into a cemetery for the more than 7,500 who fell in battle. Wills invited Edward Everett, one of the most famous orators of the day, to deliver a speech at the cemetery's dedication. Almost as an afterthought, Wills also sent a letter to Lincoln—just two weeks before the ceremony—requesting "a few appropriate remarks" to consecrate the grounds.

At the dedication, the crowd listened for two hours to Everett before Lincoln spoke. Lincoln's address lasted just two or three minutes. The speech reflected his redefined belief that the Civil War was not just a fight to save the Union, but a struggle for freedom and equality for all, an idea Lincoln had not championed in the years leading up to the war. Reception of Lincoln's Gettysburg Address was initially mixed, divided strictly along partisan lines. Nevertheless, the "little speech," as he later called it, is thought by many today to be the most eloquent articulation of the democratic vision ever written.



"The Gettysburg Address"

Four score and seven years ago our fathers brought forth on this continent a new nation, conceived in liberty, and dedicated to the proposition that all men are created equal.

Now we are engaged in a great civil war, testing whether that nation, or any nation so conceived and so dedicated, can long endure.

We are met on a great battlefield of that war.

We have come to dedicate a portion of that field,

as a final resting place for those who here gave their lives that that nation might live.

It is altogether fitting and proper that we should do this.

But, in a larger sense, we can not dedicate, we can not consecrate, we can not hallow this ground.

The brave men, living and dead, who struggled here, have consecrated it, far above our poor power to add or detract.

The world will little note, nor long remember what we say here,


but it can never forget what they did here.

It is for us the living, rather, to be dedicated here

to the unfinished work which they who fought here have thus far so nobly advanced.

It is rather for us to be here dedicated to the great task remaining before us
that from these honored dead we take increased devotion to that cause
for which they gave the last full measure of devotion that we here
highly resolve that these dead shall not have died in vain
that this nation, under God, shall have a new birth of freedom

and that government of the people, by the people, for the people, shall not perish from the earth.

The Lodge Brothers will be preparing their famous Hot Dog Lunch for everyone.

There will not be a workshop in December, but they will start back the first of January. Grab a friend and come join in with the stuffing and decorating of the dolls so we can bring smiles and stress relief to our service men and women. To date, with your help, over 140,000 Dang-it Dolls have been shipped all over the world. We have volunteers ranging in age from 5 to 90 years of age. There is something for everyone to do and this is the one place where THE MORE THE MERRIER really counts.

Don't forget that Wal-Mart on Hwy 1 in West Columbia is carrying the Morning Glory stuffing now. This is the only stuffing that is used for the dolls as the other brands are too soft and silky for our purpose. We can always use stuffing donations. We are also in need of funds to ship the dolls. With the over 1500 dolls we have shipped out since our May workshop, we are really short of funds right now. Any help you can give will be appreciated. The average cost to ship a box of 25 to 30 dolls is \$35.00. Also, we have our Dang-it Doll T-shirts in black or white. Youth sizes are \$15.00, adult sizes up to 2X are \$20.00 and 3X and above are \$25.00.

New rules & regulations from the SCDNR on hunting/fishing licenses

- Disabled Veterans who are residents of SC and receiving disability benefits from the US Veterans Administration are eligible to apply for a three year disability license at no cost.

2 - Disability license holders who are at least 65 years of age are no longer required to provide a disability benefit statement when they renew a disability license. Proof of SC residency is still required.

You will need to complete a Disability Recreational Hunting and Fishing License Application located on the SCDNR website at http://www.dnr.sc.gov/licensing.html. Along with this application you will also need to submit a copy of your unexpired SC driver's license or ID card and a current copy of your disability rating letter from the Department of Veterans Affairs.

A Pilgrimage Back to Normandy "70th Anniversary of D-Day" continued from page 9

As I reflect on Mr. Red Smith, my new hero, who told me many stories of his exploits during the war. He remembered the first town his unit came through in Germany, the town of Geilenkirchen. Today, a NATO Airbase is located there. Mr. Red remembers coming upon a farm with a tractor sitting in the middle of a field. He and some buddies went to check it out and hopefully could commandeer it. He tried to crank it but no luck and then noticed there was a bullet hole in the fuel tank. His unit continued walking to their next bivouac area. He also remembers finding a small working farm in Germany but could not remember the town. On the farm were animals, a man, his wife and daughter. They were amazed when he showed them he knew how to milk a cow. He grew up on a farm in Ohio and explained to me all the intricate details on how a farm works. He misses those days and remembers them fondly. He remarked several times on trips that



the rolling hills and green fields of Normandy reminded him of home.

Mr. Red also conveyed to me that when his Engineer unit got near Paris, the unit was ordered to ride in trucks that were provided to them. He stated the top brass did not want Soldiers walking through Paris because of all the beautiful women and displaced people who might try to beg from them or take their equipment. He also fondly remembered other units riding the rails of Germany to state the war was over and this is how they found out the military maneuvering was complete. Afterward, he was shipped back to France as a POW guard for nearly two years and then was honorably discharged.

As I close this journal of our pilgrimage, I am reminded of two things: I am grateful for the service and sacrifice of America's World War II veterans and I am one proud American who appreciates freedom.

Medical Expense and Eligibility Verification Reports

Medical Expense Report (MER)

For Veterans and Surviving Spouses receiving Non-Service Connection Pension Benefits, the VA may be able to pay you at a higher rate if you identify expenses the VA considers allowable. Medical and dental expenses paid by you may be deductible from the income VA counts when determining your benefit entitlement.

Any medical or dental expenses that you paid for a member of your household (self, spouse, child, etc.) for which you were not reimbursed may also be counted. Below are examples of expenses you should include, if applicable:

• Hospital expenses • Doctor's office fees • Dental fees • Prescription/non-prescription drug costs • Vision care costs • Medical insurance premiums • Monthly Medicare deduction • Nursing home costs • Hearing aid costs • Dental fees • Home health service expenses • Expenses related to transportation to a hospital, doctor, or other medical facility.

These expenses may be listed on a **VA Form 21P-8416** – **Medical Expense Report (MER)** - and submitted anytime for the previous year. For example: Medical Expense Reports for 2013 may be submitted anytime during the calendar year of 2014.

IMPORTANT NOTES

- Do not include any expenses for which you were reimbursed. If you receive reimbursement after you have filed a MER, promptly notify the VA office handling your claim.
- If you are not sure whether a particular expense can be allowed, furnish a complete description of the purposes of the payment. The VA will let you know if an expense cannot be allowed.
- You may be asked to verify the amounts you actually paid. Keep all receipts or other documentation of payments for at least three years after the VA makes a decision on your medical expense claim. If you are unable to provide documentation of the claimed medical expenses when asked to do so by the VA, your benefits may be retroactively reduced or terminated.

Eligibility Verification Report (EVR)

Historically, beneficiaries have been required to complete a VA Form 21-0510 - Eligibility Verification Report (EVR) - each year to ensure their pension benefits continue. However under an initiative released December 20, 2012, this requirement no longer exists. Under the new initiative, the VA works with the Internal Revenue Service and the Social Security Administration to verify eligibility for Non-Service Connected Pension Benefits for Veterans and Surviving Spouses.

Eliminating these annual reports reduces the burden on Veterans, their families and survivors because they will not have to return these routine reports to the VA each year in order to avoid suspension of benefits.

IMPORTANT NOTE: If there is a significant increase or decrease in your family income or net worth, or if there is any change in your marital status of the status of your dependents you must notify the VA immediately. Fully describe the change and furnish your name, VA claim number and Social Security number. If you do not promptly notify the VA of these changes, you may end up in an overpayment in your account.

This program is for Veterans, their surviving spouse or active duty members and does have income requirements. The grant money does not have to be repaid and is distributed on a first-come first-served basis each year. The grant allows for repairs such as roofing, windows, doors or HVAC. There is so much the grant can provide for low income Veterans and their surviving spouses to improve their homes, so please call George Lesesne or Joyce Pue at the numbers on the bottom of the flyer.

Changes to the Fry Scholarship

The Veterans Access, Choice, and Accountability Act of 2014 ("Choice Act") was recently signed into law. Most of the Act pertains to Veterans health care but it also included a provision affecting GI Bill benefits, specifically the Fry Scholarship.

The Fry Scholarship was created to honor Marine Gunnery Sergeant John David Fry, 28, of Lorena, Texas. Sergeant Fry had one week left in his tour in Iraq in 2006, when he volunteered to continue working for seven more hours disarming explosive devices, despite having already sustained an injury to his hand. He made the ultimate sacrifice on March 8, 2006, in Anbar province, Iraq, when an improvised explosive device detonated. He left behind a widow and three children.

Section 701 of the Choice Act expands the Fry Scholarship to include the <u>surviving spouses</u> of Service members who died in the line of duty after September 10, 2001. Prior to this law, only children of those who died in the line of duty were eligible for this benefit. Over 1,275 children were helped under the Fry Scholarship in FY 2013.

The law states eligible spouses are entitled to receive:

- 36 months of full benefits, equal to 100% level of the Post-9/11 GI Bill; this includes tuition and fee payment, a monthly housing allowance, and a stipend for books and supplies.
- Training must start on or after January 1, 2015. Training prior to January 1, 2015, is not eligible to receive benefits under Section 701.
- A spouse has 15 years from the date of the Service Member's death to utilize benefits. If a spouse remarries, benefits end the date of the remarriage.

Some spouses, currently eligible for or already receiving benefits under the Survivors' and Dependents' Educational Assistance (DEA) program, may now be eligible for the Fry Scholarship. DEA is an educational program offering up to 45 months of education benefits to eligible dependents of Veterans who died while on active duty, as well as dependents of Veterans who died as a result of a service-connected condition or are permanently and totally disabled due to a service-related condition. Surviving spouses of service members who died in the line of duty after September 10, 2001, will have to make a one-time irrevocable election to receive either the Fry Scholarship or DEA.

He is the three anonymous heroes in The Tomb of the Unknowns, whose presence at the Arlington National Cemetery must forever preserve the memory of all the anonymous heroes whose valor dies unrecognized with them on the battlefield or in the ocean's sunless deep.

He is the old guy bagging groceries at the supermarket, palsied now and aggravatingly slow, who helped liberate a Nazi death camp and who wishes all day long that his wife were still alive to hold him when the nightmares come.

He is an ordinary and yet an extraordinary human being - a person who offered some of his life's most vital years in the service of his country, and who sacrificed his ambitions so others would not have to sacrifice theirs.

He is a solider, a savior and a sword against the darkness, and he is nothing more that the finest, greatest testimony on behalf of the finest, greatest nation ever known.

So remember, each time you see someone who has served our country, just lean over and say Thank You. That's all most people need and in most cases it will mean more than any medals they could have been awarded or were awarded.

2014 Veteran's Day Free Meals and Discounts

- 1 **Proof of Military Service**: First, most companies require some form of military ID including a U.S. Uniform Services ID Card (active/reserve/retired), Current Leave and Earnings Statement (LES), Photograph in uniform, be wearing uniform (if your service permits), Veterans Organization Card (e.g., American Legion and VFW), DD214, discharge paperwork, or other form of identification. Other restaurants and companies may only require a photo of you in uniform, or go by the honor system.
- 2 **Participation**: Second, always call ahead to verify locations, times, and participation. Many of the listed companies are franchises and may have different policies. We will do our best to keep this page updated as we find new info.

Colonial Williamsburg – Veterans, service members and dependents of currently deployed troops can get free admission tickets to the park from November $7^{th} - 11^{th}$.





The American Legion & the Oak Ridge Boys Unite

The American Legion and the Grammy Award-winning Oak Ridge Boys are uniting to raise awareness and support for needs of U.S. military Veterans, including better detection and treatment of post-traumatic stress disorder (PTSD), help with the VA benefits process, as well as education and career opportunities for those who served our nation in uniform.

The American Legion is the country's largest Veterans service organization, with 2.4 million members who work every day on behalf of the men and women who have served our nation in uniform. The Oak Ridge Boys will participate in a national fundraising and awareness campaign to support the detection and treatment of mental health issues among Veterans, 22 of whom are lost each day to suicide.

As one of country music's longest-running groups, The Oak Ridge Boys' legacy extends back to the end of World War II. The current group — which consists of lead singer Duane Allen, bass singer Richard Sterban, tenor Joe Bonsall and baritone William Lee Golden — recently celebrated more than 40 years performing together. In that time, The Oak Ridge Boys have produced more than 30 top 10 hit songs, 12 gold records, three platinum records, one double—platinum album and a double—platinum single, with combined sales totaling 41 million



records sold. They maintain a vigorous touring schedule and released a live album in April, "Boys Night Out."

Bonsall, a member of The Oak Ridge Boys since 1973, penned an inspirational biography about his Veteran parents titled *G.I. Joe and Lillie: Remembering a Life of Love and Loyalty*. Joe's father spent much of his life living with the wounds of war, both seen and unseen, as told in the book. A song by the same name was included in the Oaks' album, *Colors*. "I know firsthand the ongoing care of our nation's Veterans is critical and how it impacts the entire family unit," Bonsall said. "Uniting with The American Legion to raise awareness of those who are suffering, as my father did, is work we are proud to champion."



The American Legion has been helping Veterans cope with the invisible wounds of war since its formation in 1919, including extensive focus in the last four years to help Veterans of Iraq and Afghanistan who have suffered what are known as the "signature wounds" of today's war era: PTSD and traumatic brain injury (TBI). VA estimates that upwards of 20 percent of Veterans from the recent wars are confronting PTSD. The American Legion has met with top national authorities in mental health care, the Department of Defense, the Department of Veterans Affairs and research institutions, as well

as Veterans and caregivers, to find solutions and treatments for those who suffer with TBI and PTSD.

"The American Legion welcomes the support of The Oak Ridge Boys in our efforts to help Veterans and their families deal with the mental scars of battle," American Legion National Commander Mike Helm said. "With the generous support of the Oaks, their fans and patriotic Americans, The American Legion will be able to help more Veterans get the support and assistance they need."

Flu Shots for Veterans enrolled in VA healthcare



The William Jennings Bryan Dorn VA Medical Center is now offering the seasonal flu vaccine at no cost to Veterans to help keep them healthy.

Veterans can visit their Primary Care Clinic to get their flu shot, including their outpatient clinics during scheduled appointments or on a walk-in basis, Monday-Friday, 8 a.m. - 4 p.m.

Flu shots are also available at Dorn's Mental Health Clinics on a walk-in basis on Tuesdays, Wednesdays, Thursdays and Fridays from 9 a.m. - 1 p.m. Specialty clinics are providing flu vaccines during regularly scheduled appointments.

If a Veteran has not applied for VA health care, visit www.va.gov/healthbenefits/enroll. For more information on the flu and benefits of immunization http://www.publichealth.va.gov/flu/or call the flu hotline at 803-695-6701.

According to the Center for Disease Control, flu is a respiratory illness that spreads easily from person to person and getting a flu vaccination is the best protection against the flu. Flu season usually begins in the fall and can continue through late spring. The flu causes more than 225,000 hospitalizations and about 36,000 deaths annually.




VETERANS TRANSPORTATION SERVICES

Featured Medal: Distinguished Service Medal

Distinguished Service Medals are awarded for exceptionally meritorious and distinguished service in a position of great responsibility to the Government of the United States, and can be awarded for such service as part of a valorous act in combat, continuous acts of valor over a period of time, for distinguished service in non-combat positions of great responsibility, and even for a career of exceptionally meritorious and distinguished service in a position of great responsibility. As such, the Distinguished Service Medals are the HIGHEST awards for non-combat actions of the Department of Defense and the individual branches of service.

The DEFENSE Distinguished Service Medal became the NEWEST of these awards when it was authorized on July 9, 1920. It is presented by the Department of Defense, and as such, takes precedence over the DSMs of the branches of service.

Both the Army and Navy Distinguished Service Medals were established in 1918 and 1919 respectively, as part of the new Pyramid of Honor that came out of the Medal of Honor review of 1917. They were part of the program to authorize new awards for presentation to Veterans of World War I who performed heroically, gallantly, and/or meritoriously during the war but whose service and/or actions did not rise to the level demanded for award of the Medal of Honor. (Until 1942 the Navy DSM took precedence over the Navy Cross.)

During World War II, a Distinguished Service Medal was authorized to members of the United States Merchant Marines by Congressional Action in 1942 and was retroactive to September 3, 1939, encompassing the period of service of Merchant Mariners in the earliest days before the United States entered World War I. Since Merchant Mariners were auxiliary to the Navy and today are not employed under the Department of Defense, they are NOT eligible for the Medal of Honor (restricted to members of the U.S. Military), making it the USMM's highest award.

Members of the U.S. Coast Guard, unlike the Merchant Marines, were eligible for award of the Medal of Honor, and one Coast Guardsman was in fact posthumously awarded the Medal of Honor in World War II. Members of the Coast Guard are also eligible for award of the Navy Cross (earning 55 in history), as well as the NAVY Distinguished Service Medal. In 1949, however, the Coast Guard was authorized its own unique, Coast Guard Distinguished Service Medal. (The award has undergone variations as a result of the post-911 transfer of the Coast Guard to the Department of Homeland Security.)

Until 1947 members of the Air Service, Air Corps, and Air Forces were adjunct to the U.S. Army, and as such were awarded the Army Medal of Honor, Army Distinguished Service Cross, and Army Distinguished Service Medal. Subsequent to establishment of the U.S. Air Force as a separate branch of service, however, members of our newest branch of military continued to receive Army awards until the Air Force established its own Air Force Medal of Honor, Air Force Cross, and Air Force Distinguished Service Medal in 1960.
