From the Director...





Special Monthly Compensation (SMC)



The U.S. Department of Veterans Affairs' (VA) Special Monthly Compensation (SMC) program may provide you with benefits in addition to, or instead of, your disability compensation if you have loss (or loss of use of) a limb, sight, speech, hearing, mobility, sexual organ or functioning, or if you have certain other disabilities. You may also be eligible for SMC if you are unable to leave your house or bed without help, or in need of regular help from another person in your daily activities. Extra VA disability or SMC is given for some especially serious disabilities. The basic idea is that the VA wants to give additional disability pay in cases where the disability is so severe that the regular ratings just aren't enough.

Unlike disability compensation, which compensates you for lost wages, SMC compensates you for non-economic losses, such as your personal inconvenience and loss of use of a body part, or body system. SMC is one of the most complex VA programs. SMC is difficult to understand and even experts in Veterans' benefits can find it confusing, so you are not alone if you find the SMC program difficult to figure out.



There are different categories that determine the type and amount of SMC. Each one has different requirements for the kind of conditions that qualify for SMC under that category. For a condition to qualify under any category, it must be determined by the VA to be a service connected disability. There are about 60 levels of SMC divided into nine letter categories: "K", "L", "M", "N", "O", "P", "R", "S", and "T". If you get SMC, the VA will tell you which of these categories of SMC you qualify for. Some of the letter categories also have in-between levels, which are shown by a "1/2" symbol after the letter. The December 2015 rates for a single Veteran range from \$103.23 to \$8318.95 per month. For a complete listing for the SMC rates visit www.benefits.va.gov/compensation/SMC. There is some specific terminology relating to SMC benefits. This terminology is explained below.



1 – Loss or Loss of Use is described as either an amputation or, having no effective remaining function of an extremity or organ. The disabilities VA can consider for SMC include:

- ◇ loss, or loss of use, of a hand or foot
- ◇ immobility of a joint or paralysis
- ◇ loss of sight of an eye (having only light perception)
- ◇ loss, or loss of use, of a reproductive organ
- ◇ complete loss, or loss of use, of both buttocks
- ◇ deafness of both ears (having absence of air and bone conduction)
- ◇ inability to communicate by speech (complete organic aphonia)
- ◇ loss of a percentage of tissue from a single breast, or both breasts, from mastectomy or radiation treatment

2015 Veteran's Day Free Meals and Discounts

Two things to always remember during Veterans Day when using any of the free meals or discounts listed below:

1 - **Proof of Military Service:** First, most companies require some form of military ID – including a U.S. Uniform Services ID Card (active/reserve/retired), Current Leave and Earnings Statement (LES), Photograph in uniform, be wearing uniform (if your service permits), Veterans Organization Card (e.g., American Legion and VFW), DD214, discharge paperwork, or other form of identification. Other restaurants and companies may only require a photo of you in uniform, or go by the honor system.

2 – **Participation:** Second, always call ahead to verify locations, times, and participation. Many of the listed companies are franchises and may have different policies. We will do our best to keep this page updated as we find new information.



Discounts at Restaurants

Applebee's – Applebee's is again offering a free meal to military Veterans and active-duty service members on November 11th. There will be 7 entrées to choose from, beverage and gratuity not included. Military ID or proof of service is required. Last year over a million free meals were served.

FATZ – Free meal for current and former military members up to \$13 value. Proof of service is required.

If you are a Veteran, retired, currently serving, in the National Guard or Reserves, you are invited to participate in Golden Corral's Military Appreciation Monday dinner. Free Park Admissions for Veterans Day



Colonial Williamsburg – Veterans, service members and dependents of currently deployed troops can get free admission tickets to the park from November 7th – 11th.

Free Entrance Into National Parks – This freebie is in honor of Veterans Day but everyone can take part in it. Over 100 national parks will waive admission fees on November 11th in honor of Veteran's Day.

Knotts Berry Farm– Knott's Berry Farm continues its tradition of honoring the brave men and women who have served in the U.S. military, both past and present, with free admission during its 25th annual Military Tribute. The free -admission offer applies to all U.S. Veterans, retired and active military personnel and one guest. Up to six additional tickets may be purchased at Knott's Ticket Booths for only \$24 each from November 2 through 21 and for \$29 each from November 22 through January 4, 2015. U.S. Veterans, retired and active military personnel must present military ID or proof of U.S. military service at Knott's ticket booths to receive the complimentary tickets. SeaWorld Parks & Entertainment – Veterans get 50% off tickets now through November 11th. The tickets must be used by December 21st. Veterans promotion includes SeaWorld Orlando, SeaWorld Antonio, SeaWorld San Diego, Busch Gardens Tampa, Busch Gardens Williamsburg, and Sesame Place Langhorne. The program does not include Discovery Cove in Orlando or Aquatica, SeaWorld's Water Park. Active duty military members who have already used their free admission for the year can also get 50% off tickets.

THANKSGIVING DAY



Thanksgiving Day is a national holiday celebrated primarily in the United States and Canada as a day of giving thanks. In the United States, the modern Thanksgiving holiday tradition is commonly, but not universally, traced to a sparsely documented 1621 celebration at Plymouth in present-day Massachusetts. The 1621 Plymouth feast and thanksgiving was prompted by a good harvest. Pilgrims and Puritans who began emigrating from England in the 1620s and 1630s carried the tradition of Days of Fasting and Days of Thanksgiving with them to New England. George Washington proclaimed the first nationwide thanksgiving celebration in America marking November 26, 1789, "as a day of public thanksgiving and prayer to be observed by acknowledging with grateful hearts the many and signal favours of Almighty God".

Thanksgiving in the United States was observed on various dates throughout history. From the time of the Founding Fathers until the time of Lincoln, the date Thanksgiving was observed varied from state to state. The final Thursday in November had become the customary date in most U.S. states by the beginning of the 19th century. Thanksgiving was first celebrated on the same date by all states in 1863 by a presidential proclamation of Abraham Lincoln. Lincoln proclaimed the date to be the final Thursday in November in an attempt to foster a sense of American unity between the Northern and Southern states. Because of the ongoing Civil War and the



Confederate States of America's refusal to recognize Lincoln's authority, a nationwide Thanksgiving date was not realized until Reconstruction was completed in the 1870s. On December 26, 1941, President Franklin D. Roosevelt signed a joint resolution of Congress changing the national Thanksgiving Day from the last Thursday in November to the fourth Thursday.

The History of Mary Edwards Walker



Famed physician, Army surgeon, feminist, women's rights activist and Civil War Veteran, Mary Edwards Walker is best known for becoming the first woman to receive the Medal of Honor. She's also known for her work as an outspoken women's rights activist, for seeking to change the restrictive styles of women's fashions of her day, and for refusing to be held back by her gender.

Born on November 26, 1832, in Oswego, New York, Mary pursued a career in a traditionally male field. She enrolled at Syracuse Medical College, graduating with a Doctor of Medicine degree in 1855.


Soon after the Civil War began in 1861, Walker began volunteering as a nurse, working early on at the Patent Office Hospital in Washington, D.C. She took a break from volunteering her services in 1862 to earn a degree from the New York Hygeio-Therapeutic College in New York City, but soon returned to the war effort.

This time, she worked on the battlefield, in tent hospitals in Warrenton and Fredericksburg, Virginia. In the fall of 1863, Walker traveled to Tennessee, where she was appointed assistant surgeon, in the Army of the Cumberland, by General George H. Thomas, one of the principal commanders in the Civil War's Western Theater. She worked as a field surgeon near the Union front lines for almost two years (including Fredericksburg and in Chattanooga after the Battle of Chickamauga), then was appointed assistant surgeon of the 52nd Ohio Infantry.

She continually crossed Confederate lines to treat civilians, and in 1864, dressed in full uniform, she accidentally walked into a group of Rebel soldiers just south of the Georgia-Tennessee border. She was captured and imprisoned by the Confederate Army at Castle Thunder prison near Richmond, Va. After four months of imprisonment, she was released that August, during a prisoner exchange, and Walker was greatly pleased that she had been traded "man for man," for a Confederate Officer.



Following her release, Walker briefly returned to Washington, D.C. and soon began supervising a hospital for women prisoners and then an orphanage. Mary Walker retired from government service in June 1865. Later that year, in recognition of her courageous war efforts, she was awarded the Medal of Honor for Meritorious Service by President Andrew Johnson, becoming the first woman to receive the honor.



After the Civil War, Walker lectured on such issues as dress reform and women's suffrage, but did not support a proposed suffrage amendment, contending that the right to vote was already contained in the Constitution.

In an unfortunate turn of events, in 1917, the U.S. government changed the criteria for the Medal of Honor, restricting it to those who had engaged in actual combat with the enemy. Hundreds of medals, including Walker's, were rescinded. She refused to return hers, however, and wore it proudly until her death on February 21, 1919, in Oswego, New York. Nearly 60 years after her death, in 1977, Mary Walker's Medal of Honor was posthumously restored by President Jimmy Carter. Nearly a century later, Mary Walker remains the only female Medal of Honor recipient.

Throughout her 87 years Mary Edwards Walker combined her vocation as a doctor with a passion for writing, agitating for social reforms -- particularly women's rights --, journalism, lecturing, and tinkering with inventions. She wrote extensively, including a combination biography and commentary called "Hit". With her caustic wit she quipped, "You men are not our protectors... If you were, who would there be to protect us from?"

MINIMUM QUALIFICATIONS

INCOME GUIDELINES:

Must identify and verify all sources of income for each household member. Verification of income must be within 90 days of submission.

STATEMENT FROM FINANCIAL INSTITUTION:

Must submit last two (2) months of bank statements for all accounts.

PROPERTY TAX:

Must be paid current.

OWN OR BUYING A HOME:

Must have thirty (30) days ownership.

COPY OF DEED:

Must be registered and recorded.

DD 214:

Or other proof of service.

2 – Aid and attendance means that the condition is so severe that it requires regular (not necessarily constant) supervision by another person. This person could be a family member, home nurse, or nursing home facility. Hospitalization does NOT qualify as aid and attendance.

3 – Permanently bedridden means that the condition is so severe that the individual cannot get out of bed. This does not include periods of bed rest prescribed by a physician since the individual could still actually get out of bed. Unlike aid and attendance, if an individual is permanently bedridden the rating continues even if they are hospitalized.

The VA will pay higher rates for combinations of these disabilities such as loss or loss of use of the feet, legs, hands, and arms, in specific monetary increments, based on the particular combination of the disabilities. There are also higher payments for various combinations of severe deafness with bilateral blindness. Additional SMC is available if a Veteran is service connected for paraplegia, with complete loss of bowel and bladder control. In addition, if you have other service-connected disabilities that, in combination with the above special monthly compensation, meet certain criteria, a higher amount of SMC can also be considered.

You should contact our office or your local VA regional office for information about applying for SMC. In determining qualifications for SMC, the VA must review the medical evidence regarding the loss or loss of use and then make a decision regarding the level of SMC to be paid.



SPECIALLY ADAPTED HOUSING PROGRAM

The Specially Adapted Housing (SAH) program offers grants to certain service members and Veterans with severe service-connected disabilities to assist them in building, remodeling, or purchasing an adapted home.

WHAT IS A SPECIALLY ADAPTED HOUSING (SAH) GRANT?

The SAH grant is designed to help disabled Veterans by providing a barrier-free living environment, such as a wheelchair accessible home, that affords Veterans a level of independent living they may not otherwise enjoy. Veterans and service members with specific service-connected disabilities may be entitled to a grant for the purpose of constructing or modifying a home to meet their adaptive needs, up to the current maximum of \$70,465. The SAH grant is available to certain Veterans and service members who are entitled to disability compensation due to:



1. Loss or loss of use of both lower extremities, such as to preclude locomotion without the aid of braces, crutches, canes, or a wheelchair, or
2. Blindness in both eyes, plus loss or loss of use of one lower extremity, or
3. Loss or loss of use of one lower extremity together with (1) residuals of organic disease or injury, or (2) the loss or loss of use of one upper extremity, affecting balance or propulsion as to preclude locomotion without the aid of braces, crutches, canes, or a wheelchair or,
4. Loss or loss of use of both upper extremities at or above the elbows, or
5. A severe burn injury.

WHAT IS A SPECIAL HOUSING ADAPTATION (SHA) GRANT?

The SHA grant can be used to increase the mobility of eligible Veteran and service members throughout their residences. Veterans and service members with specific service-connected disabilities may be entitled to this type of grant, up to the current maximum of \$14,093. The SHA grant is available to certain Veterans and service members who are entitled to disability compensation due to:

1. Blindness in both eyes with 20/200 visual acuity or less in the better eye with the use of a standard correcting lens or,
2. The anatomical loss or loss of use of both hands or extremities below the elbow, or
3. A severe burn injury.

WHAT IS A TEMPORARY RESIDENCE ASSISTANCE (TRA) GRANT?

A temporary grant may be available to SAH/SHA eligible Veterans and service members who are or will be temporarily residing in a home owned by a family member. The maximum amount available to adapt a family member's home for the SAH grant is \$30,934 and for the SHA grant is \$5,523.

WHAT IS A HOME IMPROVEMENTS AND STRUCTURAL ALTERATIONS (HISA) GRANT




Veterans and service members may receive assistance for any home improvement necessary for the continuation of treatment or for disability access to the home and essential lavatory and sanitary facilities. A Veteran may receive a HISA grant in conjunction with either a SAH or SHA grant. The HISA program is available for both Veterans with service-connected disabilities and Veterans with non-service-connected disabilities. Home improvement benefits up to \$6,800 may be provided to Veterans with service-connected disabilities and up to \$2,000 may be provided to Veterans with non-service-connected disabilities.

HOW CAN YOU APPLY?

You can apply by completing VA Form 26-4555, Veterans Application in Acquiring Specially Adapted Housing or Special Home Adaptation Grant, and submitting it to your local VA Regional Loan Center. You may also apply online; please visit the Veteran's portal at www.ebenefits.va.gov to register and submit an application for Specially Adapted Housing benefits.

Camp Lejeune Updates

As part of the VA's ongoing commitment to provide care to Veterans and their families, the Department of Veterans Affairs announced that it will start the process of amending its regulations to establish presumptions of service connection for certain conditions resulting from exposure to contaminated drinking water at the U.S. Marine Corps Base, Camp Lejeune, in North Carolina.



This process is in addition to the healthcare the VA already provides for 15 conditions to eligible Veterans who were stationed at Camp Lejeune for at least 30 days between August 1, 1953 and December 31, 1987, as a result of the Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012. The VA also provides reimbursement of healthcare expenses for those 15 conditions to eligible family members who resided at Camp Lejeune during that time period.

The Secretary of Veterans Affairs recently met with senators and the Director of the Agency for Toxic Substances and Disease Registry (ATSDR) to discuss the creation of presumptions of service connection for diseases associated with the contaminated water at Camp Lejeune. The diseases that are currently being reviewed for potential presumptive service connection include kidney cancer, angiosarcoma of the liver, and acute myelogenous leukemia, which are known to be related to long-term exposure to the chemicals that were in the water at Lejeune from the 1950s through 1987. The chemicals are Benzene, Vinyl Chloride, Trichloroethylene and Perchloroethylene, which are known as volatile organic compounds, used in industrial solvents and components of fuels.

The VA will also work with ATSDR and potentially the National Academy of Sciences to evaluate the body of scientific knowledge and research related to exposure to these chemicals and the subsequent development of other diseases. The VA will carefully consider all public comments received when determining the final scope of any presumptions.

Veterans with health problems they believe are related to exposure to the water at Camp Lejeune may file a claim for disability compensation online at www.ebenefits.va.gov, or visit their local VA office.



Military Service and Social Security Benefits

Your Social Security benefit depends on your earnings, averaged over your working lifetime. Generally, the higher your earnings, the higher your Social Security benefit. Under certain circumstances, special earnings can be credited to your military pay record for Social Security purposes. The extra earnings are for periods of active duty or active duty for training. These extra earnings may help you qualify for Social Security or increase the amount of your Social Security benefit.



If you served in the military after 1956, you paid Social Security taxes on those earnings. Since 1988, inactive duty service in the Armed Forces reserves (such as weekend drills) has also been covered by Social Security.

Under certain circumstances, special extra earnings for periods of active duty from 1957 through 2001 can also be credited to your Social Security earnings record for benefit purposes.

- ◇ **From 1957 through 1967**, Social Security will add the extra credits to your record when you apply for Social Security benefits.
- ◇ **From 1968 through 2001**, you do not need to do anything to receive these extra credits. The credits were automatically added to your record.
- ◇ **After 2001**, there are no special extra earnings credits for military service.

The information below explains how you can get credit for special earnings and applies only to active duty military service earnings from 1957 through 2001.

- ◇ **From 1957 through 1977**, you are credited with \$300 in additional earnings for each calendar quarter in which you received active duty basic pay.
- ◇ **From 1978 through 2001**, for every \$300 in active duty basic pay, you are credited with an additional \$100 in earnings up to a maximum of \$1,200 a year. If you enlisted after September 7, 1980, and didn't complete at least 24 months of active duty or your full tour, you may not be able to receive the additional earnings. Check with Social Security for details.
- ◇ **If you served in the military from 1940 through 1956**, including attendance at a service academy, you did not pay Social Security taxes. However, your Social Security record may be credited with \$160 a month in earnings for military service from September 16, 1940, through December 31, 1956, under the following circumstances:
 1. You were honorably discharged after 90 or more days of service, or you were released because of a disability or injury received in the line of duty; or
 2. You are still on active duty; or
 3. You are applying for survivors benefits and the Veteran died while on active duty.



You cannot receive credit for these special earnings if you are already receiving a federal benefit based on the same years of service. There is one exception: If you were on active duty after 1956, you can still get the special earnings for 1951 through 1956, even if you're receiving a military retirement based on service during that period. These extra earnings credits are added to your earnings record when you apply for Social Security benefits.

NOTE: *In all cases, the additional earnings are credited to the earnings that Social Security averages over your working lifetime, not directly to your monthly benefit amount.*





More information on C-123 Aircraft Agent Orange Exposure Claims



The Department of Veterans Affairs (VA) has determined that a select group of Air Force and Air Force Reserve personnel were exposed to herbicides through regular and repeated duties as ground, flight, or medical crew members on contaminated Operation Ranch Hand (ORH) C-123 aircraft that were used to spray Agent Orange in Vietnam.

WHO IS ELIGIBLE?

Any Air Force Veteran or Air Force Reservist who was assigned to one of the affected Reserve or active duty units as a ground, flight, or medical crew member on a contaminated aircraft and later developed a disability that has been linked to Agent Orange exposure should file a claim. VA has information indicating that few Air Force units (active duty and Reserve) had one or more of the contaminated aircraft during the period 1969 through 1986 (depending upon unit of assignment). VA compiled a list of these units and the dates on which they had the aircraft, which is publicly available at www.publichealth.va.gov/exposures/agentorange/locations/residue-c123-aircraft/index.asp

Claimants are encouraged to apply online through the eBenefits portal. You can apply by filling out VA Form 21-526EZ, Fully Developed Claim (Compensation). Please ensure that each C-123 related disability is specifically annotated (e.g., Diabetes/C-123) on *Part II, Block 14* of VA Form 21-526, or *Section I, Block 11* of VA Form 21-526EZ. Also, if you have any of the following material, please submit it with your application:

- Discharge, separation papers (DD214 or equivalent)
- USAF Form 2096 (unit where assigned at the time of the training action)
- USAF Form 5 (aircraft flight duties)
- USAF Form 781 (aircraft maintenance duties)
- Dependency records (marriage & children's birth certificates)
- Medical evidence (doctor & hospital reports)

War Dog Memorial to be Dedicated in November

The capital city is on target to get a new war memorial. This one will be dedicated to the dogs who serve or served in the military.

The bronze statue is a bit larger than life size and weighs 2,000 pounds. It was designed by renowned Illinois bronze artist, Renee Bemis. The replica shows the dog handler and the German Shepherd on point. It will sit on the bank just below where the current Vietnam memorial stands. This will be the largest war dog memorial in the entire United States.

The Monument is set to travel to North Carolina in October stopping at military bases along the way to South Carolina where it will be placed in its permanent home. The dedication is set to be on Veterans day this coming November. Founders hope to break ground and begin building the plaza where the statue will sit in September.



VA Eliminates Net Worth as Health Care Eligibility Factor

Elimination of Net Worth Makes More Veterans Eligible for Health Care

The Department of Veterans Affairs is updating the way it determines eligibility for VA health care, a change that will result in more Veterans having access to the health care benefits they've earned and deserve.

Effective 2015, the VA eliminated the use of net worth as a determining factor for both health care programs and copayment responsibilities. This change makes VA health care benefits more accessible to lower-income Veterans and brings VA policies in line with Secretary Robert A. McDonald's MyVA initiative which reorients VA around Veterans' needs.

"Everything that we do and every decision we make has to be focused on the Veterans we serve," said VA Secretary Robert A. McDonald. "We are working every day to earn their trust. Changing the way we determine eligibility to make the process easier for Veterans is part of our promise to our Veterans."

Instead of combining the sum of Veterans' income with their assets to determine eligibility for medical care and copayment obligations, VA will now only consider a Veteran's gross household income and deductible expenses from the previous year. Elimination of the consideration of net worth for VA health care enrollment means that certain lower-income, non-service-connected Veterans will have less out-of-pocket costs. Over a 5-year period, it is estimated that 190,000 Veterans will become eligible for reduced costs of their health care services.

In March 2014, VA eliminated the annual requirement for updated financial information. VA now uses information from the Internal Revenue Service and Social Security Administration to automatically match individual Veterans' income information which reduces the burden on Veterans to keep their healthcare eligibility up to date. That change better aligned VA's health care financial assessment program with other federal health care organizations.



NEW SOUTH CAROLINA POW MEDAL



South Carolina Veterans who were prisoners of war during a war time period are eligible to receive a new special state POW medal for their time in captivity. The POW medal was created by the Legislature in a June 2014 law that authorizes the Governor to present the award to South Carolina residents who are on federal POW lists. Any former POW who received an honorable discharge and is a South Carolina citizen can apply for the medal. Former prisoners from WWII, Korean War, Vietnam War, or other conflicts are also eligible. Surviving spouses or descendants can also apply for the medal once.

VA Funding to Help the Homeless

Secretary of Veterans' Affairs Robert A. McDonald announced 12.8 million dollars in renewal funding through the Grant and Per Diem (GPD) program to 20 community agencies that currently provide transitional housing with supportive services for homeless Veterans under the Transition in Place (TIP) model.

As a key component of the Department of Veterans' Affairs (VA) plan to eliminate homelessness among Veterans, VA's GPD program provides per diem payments to help public and nonprofit organizations establish and operate supportive housing for specific homeless Veteran populations, which includes the innovative TIP approach to assist homeless Veterans transition from homelessness. TIP encourages rapid movement from transitional housing to permanent housing which enables Veterans to live as independently, as possible, while increasing housing stabilization. It is also unlikely that there will be a cost of living increase from Social Security. Unfortunately, there will be an increase in the Medicare Part B premiums to \$159.30 per month.

- **Hardship** - If your income has recently changed, you may qualify for VA medical care without copays.

- **Repayment Plan** - You can establish a plan to spread your current health care debt over a specified period of time.

- **Compromise** - You can request a one-time monetary settlement eliminating your current health care debt.

- **Waiver** - You can request your current medical copay debts be waived for charges less than 6 months old (180 days). If a waiver is approved, you may also qualify to have Beneficiary Travel mileage reimbursement deductibles eliminated.

Changes to SC Laws

Recently there have been two major changes to SC laws affecting Veterans or surviving spouses.

1. **Senate Bill 153** - States that certain surviving spouses are also extended property tax exemption on one vehicle if she is eligible for DIC benefits and the Veteran was 100% P&T at the time of death. This bill took effect on June 1, 2015.

2. **Senate Bill 391** - States that active duty personnel and certain Veterans can receive in state tuition if residing in South Carolina and they do not have to meet the one year residency requirement. This bill took effect on July 1, 2015.




VA Announces New Rules Regarding Service Animals in VA Facilities

The Department of Veterans' Affairs (VA) announced that it has revised its regulation regarding the presence of animals on VA property. The updated regulation will ensure VA practices remain consistent with applicable federal law. It will also assist individuals entering VA facilities in developing a clear and consistent understanding of the criteria governing facility access for service animals.

"As I have traveled to VA facilities throughout the country, I have heard from many Veterans about what a vital role their service animals play in their lives," said Secretary of Veterans' Affairs Robert A. McDonald. "The revised regulation will ensure Veterans and employees have clear guidance regarding the presence of service animals in our facilities. VA remains committed to ensuring America's Veterans have access to the health care benefits for which they are eligible."

Under the revised regulation, only dogs that are individually trained to perform work or tasks on behalf of an individual with a disability will be considered service animals. Other animals will not be permitted in VA facilities, unless expressly allowed as an exception under the regulation for activities such as animal-assisted therapy or for other reasons such as law enforcement purposes. The regulation further confirms that service animals may access VA property subject to the same terms that govern the admission of the public to VA property, and may be restricted from certain areas on VA properties to ensure that patient care, patient safety, and infection control standards are not compromised.

Featured Medal:

United Nations Medal

The United Nations Medal is an international decoration awarded by the United Nations (U.N.) to the various world countries' militaries for participation in joint international military and police operations such as peacekeeping, humanitarian efforts, and disaster relief. The medal is ranked in militaries and police forces as a service medal. The United Nations awarded its first medal during the Korean War (1950-53). Since 1955, many additional United Nations medals have been created and awarded for participation in various United Nations missions and actions around the world.

The most common United Nations medal is the standard U.N. decoration known simply as the *United Nations Medal*. Most countries bestow this award for any action in which a member of the military participated in a joint U.N. activity.

In situations where a service member participated in multiple U.N. operations, service stars, campaign clasps, or award numbers are authorized as attachments to the United Nations Medal. These devices vary depending on the regulations of the various armed forces.

The U.N. has authorized the award of numerals to be attached to the medal ribbon. The qualification for these numerals is not to indicate the number of campaigns served in, but rather the number of qualifying periods of service, which are counted as 180 consecutive days after the initial qualifying period of ninety days.
