Fiduciary Program



The fiduciary program provides oversight of the VA's most vulnerable beneficiaries who are unable to manage their VA benefits because of injury, disease, the infirmities of advanced age, or under 18 years of age. The VA appoints fiduciaries to manage VA benefits for these beneficiaries and the VA has oversight of the VA-appointed fiduciaries to ensure that they are meeting the needs of the beneficiaries they serve. This appointment and oversight of fiduciaries is handled through fiduciary hubs. Currently, there are seven fiduciary hubs in the United States. We are lucky to have one at the Columbia VA Regional Office. This fiduciary hub handles the fiduciary claims for South Carolina, North Carolina,



Georgia and Florida. Approximately 28,000 claims are being processed through the Columbia fiduciary hub. Currently, South Carolina has 12 field examiners, roughly one examiner for every four counties in the state.



A fiduciary is an individual or entity who has been appointed by the VA to receive VA benefits on behalf of a beneficiary for the use and benefit of the beneficiary and the beneficiary's dependents. It is the VA's policy that every beneficiary has the right to manage his or her VA benefits. However, in cases where medical evidence indicates that the beneficiary cannot manage their VA benefits, the VA may decide that the beneficiary needs the assistance of a fiduciary. This determination may also be made based upon notice that a

court has appointed a guardian for the beneficiary. The VA's decision that a beneficiary needs a fiduciary may be appealed to the Board of Veterans Appeals.

In deciding who should act as fiduciary for a beneficiary, the VA will always select the most effective and least restrictive fiduciary arrangement. This means that the VA will first consider whether the beneficiary can manage their VA benefits with limited VA supervision under supervised direct pay. The VA will consider the choice of the beneficiary, this could be the beneficiary's spouse, family members, friends, or caregivers who are qualified and willing to provide fiduciary services for the beneficiary without a fee. As a last resort, the VA will consider appointment of a paid fiduciary.

Prior to appointment of a fiduciary, the VA will assess the well-being and needs of the beneficiary and the beneficiary's dependents in light of their funds. This assessment or field examination is based, in part, upon a face-to-face meeting with the beneficiary at the beneficiary's home or place of residence.

An assessment or field examination, conducted by a VA field examiner, checks the qualifications of a proposed fiduciary to include, but is not limited to: the willingness to serve and fulfill the responsibilities of a fiduciary; a face-to-face meeting with the prospective fiduciary; a credit history check; a criminal background check; and character witness interviews.

In some cases, the VA may require the appointed fiduciary to submit annual accountings and/or obtain a surety bond. The VA instructs the fiduciary regarding the duties and obligations of the position, and provides information regarding the beneficiary's needs, to include recurring monthly bills. After the initial appointment of a fiduciary, the VA conducts follow-up visits with beneficiaries and fiduciaries to monitor the beneficiary's well-being and fiduciary's performance. If the VA identifies unmet needs or adverse conditions, the VA may remove the fiduciary and appoint a new fiduciary for the beneficiary.

WHAT INFORMATION IS NEEDED AT AN ASSESSMENT/FIELD EXAMINATION?

During the assessment/field examination, please have the following information available for review by the field examiner:

- 1. Photo Identification.
- 2. The source and amount of all monthly bills, recurring expenses and income for the beneficiary.
- 3. A list of all assets, to include bank accounts, owned property, stocks, bonds, life insurance, burial plans, for the beneficiary.
- 4. A list of all current medications for the beneficiary.
- 5. Name, phone number, and address of the beneficiary's primary care doctor
- 6. Name, phone number, and address of the beneficiary's next of kin.



HOW DO I BECOME A FIDUCIARY?

If you are interested in serving as a fiduciary without a fee for a family member, friend, or person for whom you are a caregiver, please submit a request with the beneficiary's name, VA file number, and your name and contact information, to the VA Regional Office nearest you. You may obtain the address of the office nearest you by calling 1-800-827-1000.

If you are interested in being considered to serve as a fiduciary who may receive a fee, please submit your resume with a cover letter to the following e-mail address: VA_Fiduciary@va.gov. Please include your name, the name of your organization or business (if applicable), and your mailing and e-mail addresses with your request.

You have the right to appeal the VA's decision finding that you are unable to manage your VA benefits. You also have the right to appeal the VA's selection of the fiduciary. If you disagree with the VA on either of these matters you may: 1. Appeal to the Board of Veterans' Appeals by telling the VA you disagree with

their decision and want the Board to review it, or

2. Give the VA evidence we do not already have that may lead them to change their decision. You may also request to have your ability to manage your VA benefits re-evaluated, or to have a new fiduciary appointed, at any time. If you wish to have a re-evaluation, please submit your request in writing with any supporting medical evidence to the fiduciary hub of jurisdiction.

The Brady Handgun Violence Prevention Act prohibits you from purchasing, possessing, receiving or transporting a firearm or ammunition if you have "been adjudicated as a mental defective or been committed to a mental institution." In compliance with this act, the VA reports the names of incompetent beneficiaries to the Federal Bureau of Investigations (FBI), which then adds the names to a database called the National Instant Criminal Background Check System (NICS). Gun dealers must check NICS for the name of a potential buyer before selling him/her a firearm. You may be fined and/or imprisoned if you knowingly violate this law. You may apply to the VA for relief of firearms prohibitions imposed by the law by submitting your request to the VA. The VA will determine whether such relief is warranted.

The determination that you are unable to manage your VA benefits does not affect your non-VA finances, or your right to vote.

VA Expands Health Care

For Camp Lejeune Veterans

The VA issued a final rule to expand VA health care eligibility for Veterans affected by contaminated drinking water at Camp Lejeune. Veterans who served at least 30 days at Camp Lejeune from August 1, 1953 through December 31, 1987, are eligible to receive no cost health care for 15 medical conditions that have been linked to the contaminated water. Previously, only Veterans who served at Camp Lejeune from January 1, 1957 were covered. Veterans who have been diagnosed with any of the 15 medical conditions may



receive reimbursement for the cost of treatment if the care was provided on or after December 16, 2014, when the law expanding eligibility was signed. However, Veterans must submit a request for reimbursement no later than July 18, 2018. For more information on benefits and services for Camp Lejeune Veterans, visit: http://www.publichealth.va.gov/exposures/camp-lejeune.

This rule does not impact disability compensation benefits. The VA is still in the process of finalizing a rule to grant Camp Lejeune Veterans presumptive disability compensation for 8 of the 15 medical conditions found to be associated with exposure to the contaminated water at Camp Lejeune. However, Veterans who have been diagnosed with any of the 15 conditions should file a claim when possible to preserve the effective date.

SC Help is intended to assist borrowers who are facing first mortgage delinquency or possible foreclosure. There is no household income limit, the property must be an owner occupied primary residence, applicants must have a minimum 24 months homeownership history and applicants do NOT have to be delinquent.

Military Retirement and VA Benefits

If you are retired from the military and are also eligible for VA disability compensation, determining how much you get paid, and from where, can seem complicated. You see, until 2004, it was against the law to receive military retirement pay and VA disability compensation at the same time. Retirees had to choose which pay they wanted to receive, and if they chose to receive their VA disability compensation, those funds were "offset," or deducted, from their military retirement pay. There have been two major changes to this law in the past decade, and some Veterans may be eligible to receive their full military retirement pay along with their VA disability compensation.



Military retirement pay and VA disability compensation are entirely separate forms of compensation. They are paid from different agencies, and paid from different sources of money. They also represent two different forms of compensation. Military retirement pay is a pension that is based on your years of service. VA disability compensation is a monetary award that is based on your decreased ability to perform work after leaving the military. Military retirement pay is taxable by the federal level, and is taxed by most states (some states do not have an income tax or do not tax military retirement pay). VA disability compensation, however, is considered non-taxable income by the federal government.



What Happens When You Are Eligible to Receive Retirement Pay & Disability Compensation? To best answer this question, we need to examine your disability rating. If you have a combined disability rating of 50% or greater, you should be eligible to receive CRDP. If you receive CRDP, you will receive your full military retirement pay along with your full VA disability compensation. There will be no reduction to your military retirement pay. If you have a combined VA service-connected

disability rating of 40% or lower, then you are not eligible for CRDP and your military retirement pay will be offset, or deducted, by the amount of VA service-connected disability compensation you receive.

November 4, 1922 - King Tut's tomb was discovered at Luxor, Egypt, by British archaeologist Howard Carter.

2016 Veteran's Day Free Meals and Discounts



<u>Two things to always remember during Veterans Day when</u> using any of the free meals or discounts listed below:

1 - **Proof of Military Service**: First, most companies require some form of military ID – including a U.S. Uniform Services ID Card (active/reserve/retired), Current Leave and Earnings Statement (LES), Photograph in uniform, be wearing uniform (if your service permits), Veterans Organization Card (e.g., American Legion and VFW), DD214, discharge paperwork, or other form of identification. Other restaurants and companies may only require a photo of you in uniform, or go by the honor system.

2 – **Participation**: Second, always call ahead to verify locations, times, and participation. Many of the listed companies are franchises and may have different policies. We will do our best to keep this page updated as we find new information.

Discounts at Restaurants

Veterans Day is an official United States public holiday, observed annually on November 11th, that honors military Veterans, that is, persons who served in the United States Armed Forces. Veterans Day, formerly known as Armistice Day, was originally set as a U.S. legal holiday to honor the end of World War I, which officially took place on November 11, 1918. In legislation that was passed in 1938, November 11 was "dedicated to the cause of world peace and to be hereafter celebrated and known as 'Armistice Day.'" As such, this new legal holiday honored only World War I Veterans. In 1954, after having been through both

World War II and the Korean War, the 83rd U.S. Congress -- at the urging of Veterans service organizations -- amended the Act of 1938 by striking out the word "Armistice" and inserting the word "Veterans." With the approval of this legislation on June 1, 1954, November 11th became a day to honor American Veterans of <u>all</u> wars. It also coincides with other holidays, including Armistice Day and Remembrance Day, celebrated in other countries to mark the anniversary of the end of World War I.

I heard the bells on Christmas Day Their old, familiar carols play, and wild and sweet The words repeat Of peace on earth, good-will to men!

And thought how, as the day had come, The belfries of all Christendom Had rolled along The unbroken song Of peace on earth, good-will to men!

VA Launches Veterans Legacy Program

The Department of Veterans Affairs (VA) announced the launch of the Veterans Legacy Program to memorialize Veterans' service and sacrifice through public educational programming. The program uses the rich resources found throughout VA national cemeteries, Soldiers' lots and monument sites.

"The Veterans Legacy Program is meant to bring to life the stories of Veterans buried in the VA national cemeteries through lesson plans, interactive maps and video vignettes," said Secretary of Veterans Affairs, Robert A. McDonald. "Behind every marker is a story—a story of what it meant to be a Soldier, Sailor, Airman, Marine and Coast Guardsman at a particular moment in time. Our goal is to ensure that our nation does not forget their stories and their sacrifice."

Using online educational products such as lesson plans, interactive maps and short video vignettes, the

VA, through the Veterans Legacy Program, will engage the general public, students and educators. The VA launched this initiative earlier this year at two pilot sites: Beaufort National Cemetery in South Carolina and Riverside National Cemetery in California. Over the next several years, online educational products and programs will be developed for all the VA national cemeteries.

The VA has also formed a partnership with the American Battle Monuments Commission (ABMC) to co-sponsor a "Teachers Institute," a workshop for educators who will conduct research at the VA and the



ABMC cemeteries. Information about the program may be found at www.cem.va.gov/cem/legacy/. More than 4 million Americans, including Veterans of every war and conflict, are buried in the VA's 133 national cemeteries. The VA also provides funding to establish, expand, improve, and maintain 100 Veterans cemeteries in 47 states and territories including tribal trust lands, Guam and Saipan. For Veterans not buried in a VA national cemetery, the VA provides headstones, markers or medallions to commemorate their service. In 2015, the VA honored more than 353,000 Veterans and their loved ones with memorial benefits in national, state, tribal and private cemeteries.

VA HEALTHCARE VERSUS MEDICARE

You can have both Medicare and Veterans Affairs (VA) benefits. However, Medicare and VA benefits do not work together. Medicare does not pay for any care that you receive at a VA facility.

- In order for Medicare to cover your care, you must receive care at a Medicare certified facility that works with your Medicare coverage.
- In order for your VA coverage to cover your care, you must generally receive health care services at a VA facility.

Medicare Part B and VA Coverage:

Many Veterans use their VA health benefits to get coverage for health care services and items not covered by Medicare, such as over-the-counter medications, annual physical exams and hearing aids. However, you may want to consider enrolling into Medicare Part B (medical insurance), even if you have VA coverage. Part B may cover services you receive from Medicare-certified providers and provide you with medical coverage outside the VA health system. In addition, if you do not enroll into Part B when you are first eligible to do so, you will most likely incur a Part B premium penalty for each 12-month period you were without Medicare Part B coverage. In addition, you may also experience gaps in coverage.

Medicare Part D and VA Coverage:

Some Veterans only use their VA drug coverage to get their medications, since VA drug coverage may offer more generous prescription drug coverage than Medicare Part D, the Medicare prescription drug benefit. Since VA drug coverage is considered creditable, meaning it is as good as or better than the Medicare

prescription drug benefit, you can delay enrolling into Medicare Part D without penalty. If you do lose VA drug coverage, make sure you enroll into a Part D plan within 63 days of losing your VA benefits.

Note that although you can have both Medicare Part D and VA drug coverage, the two do not work together. VA benefits only cover the drugs you get from VA pharmacies and Part D plans usually only cover drugs you get from pharmacies that are within the plan's network. You may want to join a Part D plan in certain situations. You may want to enroll in a plan if you move into a nursing home outside of the VA health system and need coverage for medications from the nursing home pharmacy. You may also want to enroll in a Part D plan if you qualify for Extra Help, the federal assistance program that helps people with Medicare afford their Part D drug costs.

The History of John Philip Sousa

John Philip Sousa was born in Washington, D.C., on November 6, 1854, as the third of ten children of John Anthony Sousa and Maria Elisabeth Trinkhaus. Sousa started his music education by playing the violin and studying music theory and composition at the age of six, where he was found to have absolute pitch. During his childhood, Sousa studied voice, violin, piano, flute, cornet, baritone horn, trombone, and alto horn. On December 30, 1879, Sousa married Jane van Middlesworth Bellis. They had three children: John Philip, Jr., Jane Priscilla, and Helen.





When Sousa was 13, his father, a trombonist in the Marine Band, enlisted him in the United States Marine Corps as an apprentice to keep him from joining a circus band, and his initial rank was listed as "boy". Sousa re-enlisted on July 8, 1872 and was promoted to musician. He left the Marine Corps in 1875 at the age of 20. After leaving the Marine Corps, Sousa joined a theatrical (pit) orchestra where he learned to conduct. His second period of Marine service was from 1880 to 1892 and during this period, he was the leader of the Marine Band in Washington, D.C. Sousa's salary as "leader of the band" (his official Marine Corps rank) was \$83 per month. Under his leadership, the Marine Band became the premier military band in the United States. In July 1892, Sousa requested, and received, a discharge from the Marine Corps to pursue a financially promising civilian career as a band leader. He organized the Sousa Band the year he left the Marine Band. The Sousa Band toured from 1892 to 1931, performing at 15,623 concerts in both America and around the world.

On May 31, 1917, shortly after the United States declared war on Germany and entered World War I, Sousa was commissioned as a lieutenant in the United States Naval Reserve. At that time, Sousa was 62 years old which was then the mandatory retirement age for Navy officers. Sousa was discharged from active duty after the war's end in November 1918. He returned to conducting his own band but continued to wear his naval uniform for many of his concerts and other public appearances. For this service during the war, Sousa received the World War I Victory Medal. During World War II, the Liberty ship, SS *John Philip Sousa* was named after him. The ship's bell is still used by the Marine Band in concert.





The marching brass bass, or sousaphone was created by J. W. Pepper, a Philadelphia instrument maker, who created the instrument in 1893 at Sousa's request using several of his suggestions in its design. Sousa wanted a tuba that could sound up and over the band whether its player was seated or marching. The sousaphone was re-created in 1898 by C.G. Conn and the instrument is named after _Sousa, who popularized its use in his band and it was the model that Sousa preferred to use.

Sousa wrote 137 marches, 15 operettas, 5 overtures, 11 suites, 24 dances, 28 fantasies, and 322 arrangements of nineteenth-century western European symphonic works. Including: "Semper

Fidelis" (Official March of the United States Marine Corps); "Stars and Stripes Forever" (National March of the United States); "El Capitan"; "Hands Across the Sea" (dedicated to the band of the Virginia Tech Corps of Cadets); "U.S. Field Artillery" (modified version "The Army Goes Rolling Along" is the official song of the U.S. Army); and "Salvation Army March". Sousa wrote marches for several American universities, including the University of Minnesota, University of Illinois, University of Nebraska, Kansas State University, and Marquette University. In 1987, an act of Congress named "The Stars and Stripes Forever" as the National March of the United States.



Sousa died of heart failure at the age of 77 on March 6, 1932, in his room at the Abraham Lincoln Hotel in Reading, Pennsylvania. He had conducted a rehearsal of "The Stars and Stripes Forever" the previous day with the Ringgold Band. He is buried in Washington, D.C.'s Congressional Cemetery.

Veterans Get Telephonic Health Care Application Option

The Department of Veterans Affairs (VA) has announced that it is



amending its enrollment regulations to allow Veterans to complete applications for enrollment in VA health care by telephone without the need for a signed paper application. The change is effective immediately for Combat Veterans and will be effective July 5, 2016, for all Veterans. This phased implementation accelerates the VA's effort to enroll all Combat Veterans with pending applications as part of its ongoing Veterans Enrollment Rework Project. The VA is working to complete the review and rework of all pending health enrollment records for living and deceased Veterans this summer. By adding this telephone application option to the VA's regulations, the VA will now offer three ways to enroll. This change provides Veterans an even more convenient way to apply for enrollment, in addition to the paper VA Form 10-10EZ and online enrollment application process. NEW SOUTH CAROLINA POW MEDAL

South Carolina Veterans who were prisoners of war during a war time period are eligible to receive a new special state POW medal for their time in captivity. The POW medal was created by the Legislature in a June 2014 law that authorizes the Governor to present the award to South Carolina residents who are on federal Any former POW lists. POW who received an



honorable discharge and is a South Carolina citizen can apply for the medal. Former prisoners from WWII, Korean War, Vietnam War, or other conflicts are also eligible. Surviving spouses or descendants can also apply for the medal once.

The Audiology and Optometry Direct Scheduling Initiative is expected to be fully operational within all VA Medical Centers by the end of 2016.

Featured Medal: Medal of Honor

The Medal of Honor is the United States of America's highest military honor, awarded for personal acts of valor above and beyond the call of duty. The medal is awarded by the President of the United States in the name of the U.S. Congress to U.S. military personnel only. There are three versions of the medal, one for the Army, one for the Navy, and one for the Air Force. Personnel of the Marine Corps and Coast Guard receive the Navy version. It is sometimes known by its initials "MH", but the initials are not used by recipients as a post-nominal title.

The Medal of Honor was created as a Navy version in 1861 named the "Medal of Valor", and an Army version of the medal named the "Medal of Honor" was established in 1862 to give recognition to men who distinguished themselves "conspicuously by gallantry and intrepidity" in combat with an enemy of the United States. Because the medal is presented "in the name of Congress", it is often referred to as the "Congressional Medal of Honor". However, the official name is the "Medal of Honor", which began with the U.S. Army's version. Within United States Code the medal is referred to as the "Medal of Honor", and less frequently as "Congressional Medal of Honor".

The Medal of Honor is usually presented by the President in a formal ceremony at the White House, intended to represent the gratitude of the American people, with posthumous presentations made to the primary next of kin. According to the Medal of Honor Historical Society of the United States, there have been 3,515 Medals of Honor awarded to the nation's Soldiers, Sailors, Airmen, Marines, and Coast Guardsmen since the decoration's creation, with just less than half of them awarded for actions during the four years of the American Civil War.

In 1990, Congress designated March 25 annually as "National Medal of Honor Day". Due to its prestige and status, the Medal of Honor is afforded special protection under U.S. law against any unauthorized adornment, sale, or manufacture, which includes any associated ribbon or badge.
