

Appeals Modernization Program



What is Appeals Modernization?

On August 23, 2017, the President signed the Veterans

Appeals Improvement and Modernization Act of 2017 (Appeals

Modernization Act) into law, creating a new decision review

process that allows VA to improve the delivery of benefits

and services to Veterans and their families. The new process

gives Veterans choice and control, and all communications are

written in plain language.

The new Appeals Modernization process allows Veterans to seek faster resolution of their disagreement with a VA decision. If you receive an initial claim decision after February 2019 and you disagree, you can choose one of three new lanes to have your disagreement reviewed: as a supplemental claim, through a higher-level review, or by appealing directly to the Board of Veterans' Appeals. The Appeals Modernization Act establishes a new decision review process for disagreements with VA decisions that is timely, transparent and fair.



Veterans in the legacy appeals process who receive a Statement of the Case (SOC) or Supplemental Statement of the Case (SSOC) after February 2019 will be eligible to opt-in to the new Appeals Modernization process.

Which Review Lane is Right For You?

Supplemental Claim Lane (decisions within 125 days on average)

- Select this option if you have additional evidence that is new and relevant to support your benefit claim.
- VA will assist you in gathering new and relevant evidence to support your claim.
- VA's review will include any new and relevant evidence submitted since we last decided your claim.

Higher-Level Review Lane (decisions within 125 days on average)

- A higher-level review consists of an entirely new review of your claim by a more experienced claims adjudicator.
- Select this option if you have no additional evidence to submit in support of your claim, but you believe that there was an error in the initial decision.
- WA cannot assist you in gathering new evidence, but if the higher-level reviewer discovers an error in VA's duty to assist in the prior decision your claim will return to decision makers to correct the error.
- You or your representative can request an optional, one-time, informal telephone conference with the higher-level reviewer to identify specific errors in the case, although this may cause a delay in the processing of your higherlevel review.

Appeal to the Board Lane

- If you choose the Board, select one of the three following options:
 - Olirect Review
 You do not want to submit
 additional evidence or have
 a hearing.
 - Evidence Submission
 You choose to submit
 additional evidence without
 a hearing. You will have 90
 days from your Notice of
 Disagreement (NOD) to
 submit any additional evidence.
 - Hearing
 You choose to submit
 additional evidence and have
 a hearing with a Veterans Law
 Judge. You will be scheduled
 for a Board hearing and may
 submit evidence at the
 hearing or within the 90 day
 window following the
 scheduled hearing.

What If You **Still Disagree**with a Decision?

If you disagree with a decision from the Supplemental Claim Lane, you may choose to resubmit the daim as another supplemental claim with new evidence, as a higher-level review or as an appeal to the Board of Veterans' Appeals.

If you disagree with a decision from the Higher-Level Review Lane, you may choose to resubmit the daim as a supplemental daim or as an appeal to the Board of Veterans' Appeals.

If you disagree with a Board decision you may either resubmit as a supplemental claim or through an appeal to the U.S. Court of Appeals for Veterans Claims.





VIETNAM BLUE WATER NAVY VETERANS

Disability benefits available To those serving offshore

Agent Orange Exposure in the Republic of Vietnam Waters (Blue Water Navy)

Blue Water Navy Veterans are now entitled to a presumption of service connection for conditions related to Agent Orange exposure. This extension of the presumption is a result of Public Law 116-23, the Blue Water Navy Vietnam Veterans Act of 2019, signed into law on June 25, 2019. The law takes effect January 1, 2020.

The law states that Veterans aboard a vessel operating not more than 12 nautical miles seaward from the demarcation line of the waters of Vietnam and Cambodia as defined in Public Law 116-23, between January 9, 1962, and May 7, 1975, are presumed to have been exposed to herbicides such as Agent Orange and may be entitled to service connections for conditions related to that exposure.

To be entitled to disability compensation benefits, these Veterans must have one or more of the conditions associated with Agent Orange exposure that are listed in 38 Code of Federal Regulations section 3.309€.

What conditions are related to Agent Orange exposure?

Agent Orange presumptive conditions are:

- AL amyloidosis
- Chlordane, or other acneform disease consistent with chlorance
- Chronic B-cell leukemias
- Diabetes mellitus, Type 2
- Ischemic heart disease
- Hodgkin lymphoma, formerly known as Hodgkin's disease
- Non-Hodgkin lymphoma
- Multiple myeloma
- Parkinson's disease
- Peripheral neuropathy, early-onset
- Porphyria cutanea tarda
- Prostate cancer
- Respiratory cancers (lung, bronchus, larynx or trachea)
- Soft tissue sarcoma (other than osteosarcoma, chondrosarcoma, Kaposi's sarcoma, or mesothelioma).

How do I file a claim for disability compensation?

- Apply online using www.va.gov, OR
- Work with an accredited representative or agent, OR
- Go to a VA regional office and have a VA employee assist you.
- 1. You must state on your application that you are filing or one of the presumed Agent Orange conditions.
- Include any evidence you have of service in the offshore waters of the Republic of Vietnam during the required timeframe. Include the name(s) of the ship(s) and the date(s) you crossed within 12 nautical miles of the Republic of Vietnam, if you have that information.
- Provide medical evidence showing a diagnosis of the current Agent Orange presumptive condition or tell the VA where you are being treated.

The Blue Water Navy Act of 2019 will take effect on January 1, 2020. Veterans can file claims at any time, and they will be decided after the law is implemented. Blue Water Navy claims and appeals currently in process have been placed on hold (stayed) until the new rules go into effect. The bipartisan Blue Water Navy Vietnam Veterans Act gives the VA until January 1, 2020, to begin deciding Blue Water Navy related claims. By staying claims decisions until that date, the VA is complying with the law that congress wrote and passed.

Incarcerated Veterans/Fugitive Felons

ncarcerated Veterans

Veterans can sometimes run into issues with law enforcement and the criminal justice system resulting in incarceration. It is important that justice-involved Veterans are familiar with VA benefits including what VA benefits they may still be eligible to receive, what happens to the VA benefits they are already receiving if they become incarcerated, and what programs are available to assist them with reintegrating back into the community once released from incarceration. Despite the circumstances, some justice-involved Veterans may be eligible for VA benefits. Please be aware many VA benefits can be affected by incarceration.



VA Programs for Justice-Involved Veterans

Health Care for Re-entry Veterans (HCRV) Program

The HCRV Program is designed to help incarcerated Veterans successfully reintegrate back into the community after their release. A critical part of HCRV is providing information to Veterans while they are incarcerated, so they can plan for re-entry themselves. A primary goal of the HCRV program is to prevent Veterans from becoming homeless once they are reintegrated back into the community.

Veteran Justice Outreach (VJO) Initiative

The VJO initiative is designed to help Veterans avoid unnecessary criminalization of mental illness and extended incarceration by ensuring eligible justice-involved Veterans receive timely access to VA health care, specifically mental health and substance use services (if clinically indicated) and other VA services and benefits as appropriate.

How Incarceration Affects Eligibility for VA Benefits

The VA can pay certain benefits to Veterans who are incarcerated in a Federal, State, or local penal institution; however, the amount depends on the type of benefit and reason for incarceration.

Disability Compensation

VA disability compensation payments are reduced if a Veteran is convicted of a felony and imprisoned for more than 60 days. Veterans rated 20 percent or more are limited to the 10 percent disability rate. For a Veteran whose disability rating is 10 percent, the payment is reduced by one-half. Once a Veteran is released from prison, compensation payments may be reinstated based upon the severity of the service connected disability(ies) at that time. Payments are not reduced for recipients participating in work release programs, residing in halfway houses (also known as "residential re-entry centers"), or under community control. The amount of any increased compensation awarded to an incarcerated Veteran that results from other than a statutory rate increase may be subject to reduction due to incarceration.

Pension

Veterans in receipt of VA pension will have payments terminated effective the 61st day after imprisonment in a Federal, State, or local penal institution for conviction of a felony or misdemeanor. Payments may be resumed upon release from prison if the Veteran meets VA eligibility requirements. Failure to notify VA of a Veteran's incarceration could result in the loss of all financial benefits until the overpayment is recovered.

Apportionment to Spouse or Children

All or part of the compensation not paid to an incarcerated Veteran may be apportioned to the Veteran's spouse, child or children, and dependent parents on the basis of individual need. In determining individual need, consideration shall be given to such factors as the claimant's income and living expenses, the amount of compensation available to be apportioned, the needs and living expenses of other claimants as well as any special needs, if any, of all claimants.

Education Benefits

Beneficiaries incarcerated for other than a felony can receive full monthly benefits, if otherwise entitled. Convicted felons residing in halfway houses (also known as "residential re-entry centers"), or participating in work-release programs also can receive full monthly benefits. Claimants incarcerated for a felony conviction can be paid only the costs of tuition, fees, and necessary books, equipment, and supplies. VA cannot make payments for tuition, fees, books, equipment, or supplies if another Federal State or local

program pays these costs in full. If another government program pays only a part of the cost of tuition, fees, books, equipment, or supplies, VA can authorize the incarcerated claimant payment for the remaining part of the costs.

Additional Information

Each VA Regional Office has a Homeless Veterans Outreach Coordinator who assists justice-involved Veterans. They are a direct point of contact for you to learn more about what benefits you qualify for, assist you with applying for those benefits, and refer you to other organizations and resources that will help you with your specific needs. ugitive Felon Program (FFP)

The VA is prohibited from providing or continuing to provide health care and services, including medications and any care provided in the community, at VA expense to Veterans and beneficiaries identified as fugitive felons. A Fugitive Felon is defined as a person who is:

- Fleeing to avoid custody or confinement after conviction for an offense which is a felony under the laws of the place from which the person is fleeing, or for an attempt to commit such an offense; and/or
- Fleeing to avoid prosecution for an offense which is a felony; and/or
- 3. Violating a condition of probation or parole imposed for committing a felony under Federal or State law.

Termination of VA Health Care Benefits

The VA will mail a letter to the Veteran or beneficiary identified as a fugitive felon to inform them of their status and termination of all VA health care benefits. The VA staff will take appropriate steps to transition the fugitive felon's health care from VA programs to alternative care outside the VA health care system. The VA cannot pay for any of this alternative care. In addition, VA will bill the Veteran and/or beneficiaries for all VA provided care received while in this fugitive felon status.

Resolving Fugitive Felon Status

Persons identified as a fugitive felon must contact the Originating Agency that issued a felony warrant, **not the VA Police**, if it is believed:

- 1. An error was made, such as mistaken identity.
- 2. The warrant should be cancelled.
- 3. The warrant has been satisfied by your arrest or surrender.
- 4. There are other reasons, which would resolve the warrant.

Evidence that the warrant has been satisfied should be provided to your local VA regional office. For additional information concerning the Fugitive Felon Program, please contact the Fugitive Felon Coordinator or Enrollment Coordinator at your local VA medical care facility or contact VA at 1-877-222-VETS (8387).

The VA exceeds hiring goal of mental health providers by the thousands

The VA recently surpassed its original goal to hire mental health providers by more than 1,000, through the Mental Health Hiring Initiative, which aims to achieve higher standards of access and quality care. Since 2017, VA has filled nearly 4,000 mental health positions nationwide, which provides nearly 120,000 more Veterans access to high-quality mental health services each year, including those in underserved and rural regions of the country. Some of the success can be attributed to the VA hosting its first-ever external virtual trainee hiring fair, where 74 mental health professionals completed training and accepted positions at VA facilities. The department is currently planning a second, internal virtual-trainee hiring event focused on connecting, matching and retaining current VA psychology trainees and placing them into vacant positions at VA facilities. Staff were also empowered to develop facility-specific hiring and retention plans, which enabled them to hire as vacancies opened. Many facilities used national hiring announcements offering loan repayment and other incentives for attracting mental health professionals. The History of the Erie Canal

The Erie Canal is a 363-mile waterway that connects the Great Lakes with the Atlantic Ocean via the Hudson River in upstate New York. The channel, which traverses the State of New York from Albany to Buffalo on Lake Erie, was considered an engineering marvel when it first opened in 1825.

Early explorers in America had long searched for a water route from East Coast population centers to the resource-rich lands of the Midwest and Great Lakes. The Northwest Territory—which later would become the states of Ohio, Michigan, Indiana,



Illinois and Wisconsin—had timber, minerals, furs and fertile land for farming, but the Appalachian Mountains stood in the way. Throughout the 18th and early 19th centuries, it took weeks to reach these resources overland. Bulk transportation of goods was limited by what teams of oxen could pull by wagon. The lack of an efficient transportation network confined populations and trade to coastal areas.

Beginning in 1807, Jesse Hawley—a flour merchant from western New York who went broke trying to get his product to



market in the Atlantic coastal cities—published a series of essays from debtor's prison. In them, Hawley advocated for a canal system that would span nearly 400 miles from Buffalo, New York, on the eastern shore of Lake Erie, to Albany, New York, on the Hudson River. Hawley's eloquent essays caught the attention of New York politicians, including New York City mayor DeWitt Clinton. Clinton believed that the canal was crucial to the economic advancement of his city. Clinton saw his plan come to fruition in 1817 after he became the governor of New York. Workers first broke ground on the Erie Canal on July 4, 1817, near Utica, New York.

The construction of the Erie Canal, through mountainous terrain and dense rock proved as challenging as the political environment. Throughout construction, Dewitt Clinton's political opponents ridiculed the project as "Clinton's Folly" or "Clinton's ditch." It took canal laborers—some Irish immigrants, but most U.S.-born men—eight years to finish the project. They cleared the land by hand and animal power and blasted through rock with gunpowder. The original Erie Canal was just four feet deep and 40 feet wide, though it was considered a major engineering feat at the time of its completion in 1825. It traversed nearly 400 miles of fields, forests, and rocky cliffs, and contained 83 locks—structures used for raising and lowering boats between canal stretches with different water levels. Project engineers had little experience building canals. The military academy at West Point in New York offered the only formal engineering program in North America at the time the Erie Canal was built.

The Erie Canal opened on October 26, 1825. A fleet of boats, led by Governor Dewitt Clinton aboard the *Seneca Chief* sailed from Buffalo to New York City in record time—just ten days. The canal transformed New York City into the commercial capital it remains today. Prior to the canal's construction, the ports of Boston, Philadelphia and New Orleans outranked New York in size. But the construction of the Erie Canal gave New York City (via the Hudson River) direct water access to the Great Lakes and regions of the Midwest. As the gateway to these resource-rich lands, New York soon became the nation's economic epicenter and the primary port of entry to the United States for European immigrants. New York City's population quadrupled between 1820 and 1850. Financing of the Erie Canal's construction allowed the city to eclipse Philadelphia as the country's most important banking center. The canal fostered a population surge in western New York and opened regions farther west to settlement.

The Erie Canal was enlarged twice to fit wider and deeper boats. Some parts were rerouted to make way for more ship traffic in 1918. Portions of the original canal are still operable, though tourism is now the main source of boat traffic along the Erie Canal. Commercial and shipping traffic declined abruptly after the completion of the St. Lawrence Seaway in 1959. The new waterway along the United States-Canadian border allowed large ships to enter the Great Lakes directly from the Atlantic Ocean, bypassing the Erie Canal. In 2000, Congress designated the Erie Canal a National Heritage Corridor to help preserve New York State's historic waterway and the communities along its banks.



Any National Guard member or Reservist who is entitled to retired pay for non-regular service or, would be entitled to retired pay for non-regular service, now has Veteran status. To see if you qualify for any benefits, check with your local VA regional office.

Direct Deposit

What is the fastest way to enroll or make a change to your Direct Deposit? The fastest way is to call 1-800-827-1000. They will be able to change it over the phone. To enroll you will need to know your routing and account



number along with the amount that is being deposited. If you are changing your direct deposit, you will need to know your old routing and account number along with your new information.



The VA launches new health care options under the MISSION Act

The VA launched its new and improved Veterans Community Care Program on June 6, 2019, implementing portions of the VA Maintaining Internal Systems and Strengthening Integrated Outside Networks Act of 2018 (MISSION Act), which both ends the Veterans Choice Program and establishes a new Veterans Community Care Program. The MISSION Act will strengthen the nationwide VA Health Care System by empowering Veterans with more health care options. Under the new Veterans Community Care Program, Veterans can work with their VA health care provider or other VA staff to see if they are eligible to receive community care based on new criteria. Eligibility for community care does not require a Veteran to receive that care in the community; Veterans can still choose to have VA provide their care. Veterans may elect to receive care in the community if they meet any of the following six eligibility criteria:

- 1 A Veteran needs a service not available at any VA medical facility.
- 2 A Veteran lives in a US state or territory without a full-service VA medical facility. Specifically, this would apply to Veterans living in Alaska, Hawaii, New Hampshire and the US territories of Guam, American Samoa, the Northern Mariana Islands and the US Virgin Islands.
- 3 A Veteran qualifies under the "grandfather" provision related to distance eligibility under the Veterans Choice Program.
- 4 The VA cannot furnish care within certain designated access standards. The specific access standards are described below:
 - A Drive time to a specific VA medical facility
- * Thirty-minute average drive time for primary care, mental health and non-institutional extended care services.
 - * Sixty-minute average drive time for specialty care.

(Please note: Drive times are calculated using geo-mapping software.)

- B Appointment wait time at a specific VA medical facility
- * Twenty days from the date of request for primary care, mental health care and non-institutional extended care services, unless the Veteran agrees to a later date in consultation with his or her VA health care provider.
- * Twenty-eight days for specialty care from the date of request, unless the Veteran agrees to a later date in consultation with his or VA health care provider.
- 5 The Veteran and the referring clinician agree it is in the best medical interest of the Veteran to receive community care based on defined factors.
- 6 The VA has determined that a VA medical service line is not providing care in a manner that complies with the VA's standards for quality based on specific conditions.

In preparation for this landmark initiative, senior VA leaders will visit more than 30 VA hospitals across the country to provide in-person support for the roll-out.

The VA MISSION Act:

- Strengthens the VA's ability to recruit and retain clinicians.
- Authorizes "Anywhere to Anywhere" telehealth across state lines.
- Empowers Veterans with increased access to community care.
- Establishes a new urgent care benefit that eligible Veterans can access through the VA's network of urgent care providers in the community.

The VA serves approximately 9 million enrolled Veterans at 1,255 health care facilities around the country every year. For more information, visit www.missionact.va.gov.

List of Common Allowable (Recurring) Medical Expenses for an Initial Claim Application

The list below shows recurring VA allowable medical expenses for the initial claim application for pension benefits. The list is not all-inclusive and must be unreimbursed by insurance. They must be paid for by the applicant and are used to reduce income that exceeds the VA income limit.

- 1. Medicare Part B Premiums
- 2. Medicare Part D Premiums
- 3. Insurance Premiums for supplemental medical insurance
- 4. Home Health Services
- 5. Assisted Living Facility Services
- 6. Nursing Home Services
- 7. Long Term Care Insurance
- 8. Medical Monitoring Program (like Life Alert)

SC Hunting and Fishing Licenses for Disabled Veterans

Residents of SC may apply for a disability license by mail or in person at a DNR Regional Office. Offices are located in Columbia, Charleston, Clemson, Florence, York, and DNR at the Market, located at the SC State Farmer's Market in West Columbia. In order to qualify for a disability license you must be declared disabled and receiving disability benefits from one of the following agencies:

- Federal Civil Service
- Medicaid or Railroad Retirement
- SC State Retirement System
- Social Security Administration
- Veterans Affairs (the VA)



In order to qualify for a Disability license you must have been a SC resident for 365 days. DNR must have a completed application, a photocopy of your SC driver's license or SC state issued ID card and current proof (dated within the past 12 months) stating you are disabled and receiving benefits.

The license will be valid for 3 years and includes privileges of hunting, big game, WMA permit, migratory waterfowl permit and fresh and saltwater fishing.

Pension Benefits

The Department of Veterans Affairs (VA) has two types of pension programs: Non-service connected pension (NSCP) which is for Veterans and Survivors pension (also called death pension) for surviving spouses and un-remarried children (certain criteria apply/see below). Both pension benefits help Veterans and their families cope with financial challenges by providing supplemental income. Pension benefits are tax-free monetary benefits payable to low-income Veterans, surviving spouses and certain un-remarried children.

Pension for Veterans Eligibility

Generally, a Veteran must have at least 90 days of continuous active duty service, with at least one day during a wartime period (see below for wartime periods) to qualify for a VA Pension. If you entered active duty after September 7, 1980, generally you must have served at least 24 months or the full period for which you were called or ordered to active duty (with some exceptions), with at least one day during a wartime period, and was discharged from service under other than dishonorable conditions. In addition to meeting minimum service requirements, the Veteran must be:

- 1. Age 65 or older, OR
- 2. Totally and permanently disabled, OR
- 3. A patient in a nursing home receiving skilled nursing care, OR
- 4. Receiving Social Security Disability Insurance, OR
- 5. Receiving Supplemental Security Income

Income Requirements

The VA uses your total family income and net worth to determine if you meet the income requirements for the benefit. Your yearly family income must be less than the amount set by Congress to qualify for the NSCP benefit. Currently, the 2019 amount for NSCP is \$13,535/year for a single Veteran and \$17,724/year for a Veteran and spouse. The VA recently changed the way they assess net worth to make the pension entitlement rules more clear. Net worth is the total of your or beneficiary's assets and annual income. Your net worth also includes the net worth of your spouse. You should report all of your net worth. The net worth limit to qualify for a Veterans Pension as of December 1, 2018 is \$127,061. In the future, the net worth limit will increase by the same percentage as Social Security cost-of-living increases.

Additional Veteran Pension Allowances

Veterans who are eligible for VA pension and are housebound or require the aid and attendance of another person, may be eligible for an additional monetary payment. If the Veteran's spouse needs aid and attendance, the costs of their care may also be used to lower the combined income and grant benefits.

Survivors Pension

Eligibility

The deceased Veteran must have met the following service requirements:

- 1. For service on or before September 7, 1980, the Veteran must have served at least 90 days of continuous active military service, with at least one day during a war time period.(see below for wartime periods)
- 2. If he or she entered active duty after September 7, 1980, generally he or she must have served at least 24 months or the full period for which called or ordered to active duty with at least one day during a war time period.
- 3. Was discharged from service under other than dishonorable conditions.
- 4. Must be married to the Veteran at the time of their death and be un-remarried since their death.

While an un-remarried spouse is eligible at any age, a child of a deceased wartime Veteran must be:

- 1. Under 18, OR
- 2. Under age 23 if attending a VA-approved school, OR
- 3. Permanently incapable of self-support due to a disability before age 18

Pension Benefits Continued from page 20 Income Requirements

The VA uses your total family income and net worth to determine if you meet the income requirements for the benefit. Your yearly family income must be less than the amount set by Congress to qualify for the survivors benefit. Currently, the 2019 amount for survivors pension is \$9,078/year for a surviving spouse and \$11,881/year for a surviving spouse with one dependent.

The VA recently changed the way they assess net worth to make the pension entitlement rules more clear. Net worth is the total of your or beneficiary's assets and annual income. You should report all of your net worth. The net worth limit to qualify for a Veterans Pension as of December 1, 2018 is \$127,061.

Additional Survivors Pension Allowances

Surviving spouses or un-remarried children who are eligible for survivors pension and are housebound or require the aid and attendance of another person may be eligible for an additional monetary payment.

Housebound/Aid and Attendance Benefits

These benefits are paid in addition to monthly pension, and they are not paid without eligibility to pension benefits first. Since Aid and Attendance and Housebound allowances increase the pension amount, people who are not eligible for a basic pension due to excessive income may be eligible for pension at these increased rates. A Veteran or surviving spouse may not receive Aid and Attendance benefits and Housebound benefits at the same time. The current 2019 amounts for Housebound are \$16,540/year for a single Veteran; \$20,731/year for a Veteran and spouse; \$11,095/year for a surviving spouse; and \$13,893/year for a surviving spouse with one dependent. The 2019 rates for Aid and Attendance are \$22,577/year for a single Veteran; \$26,766 for a Veteran and spouse; \$14,509/year for a surviving spouse; and \$17,309 for a surviving spouse with one dependent.

The *Housebound* increased monthly pension amount may be added to your monthly pension amount when you are substantially confined to your immediate premises because of permanent disability.

The Aid & Attendance (A & A) increased monthly pension amount may be added to your monthly pension amount if you meet one of the following conditions:

- 1. You require the aid of another person in order to perform personal functions required in everyday living, such as bathing, feeding, dressing, attending to the wants of nature, adjusting prosthetic devices, or protecting yourself from the hazards of your daily environment
- 2. You are bedridden, in that your disability or disabilities requires that you remain in bed apart from any prescribed course of convalescence or treatment
- 3. You are a patient in a nursing home due to mental or physical incapacity
- 4. Your eyesight is limited to a corrected 5/200 visual acuity or less in both eyes; or concentric contraction of the visual field to 5 degrees or less

To apply for increased pension based on Housebound or A&A payments, you will need to provide medical evidence, such as a doctor's report, that validates the need for an increased benefit or complete VA Form 21-2680 "Examination for Housebound Status or Permanent Need For Regular Aid and Attendance".

Eligible Wartime Periods

Under current law, the VA recognizes the following wartime periods to determine eligibility for VA Pension benefits:

- 1. Mexican Border Period (May 9, 1916 April 5, 1917 for Veterans who served in Mexico, on its borders, or adjacent waters)
- 2. World War I (April 6, 1917 November 11, 1918)
- 3. World War II (December 7, 1941 December 31, 1946)
- 4. Korean conflict (June 27, 1950 January 31, 1955)
- 5. Vietnam era (February 28, 1961 May 7, 1975 for Veterans who served in the Republic of Vietnam during that period; otherwise August 5, 1964 May 7, 1975)
- 6. Gulf War (August 2, 1990 through a future date to be set by law or Presidential Proclamation)

How To Apply

To apply for Veterans Pension, you can download and complete VA Form 21P-527EZ, "Application for Pension" from the VA website. To apply for Survivors Pension, you can download and complete VA Form 21-534EZ, "Application for DIC, death pension, and/or accrued benefits" from the VA website. That website is: www.va.gov/forms. You may also contact our office directly and we can mail, fax, or email you a packet on the specific benefit. This packet includes all the forms needed to submit the claim, along with a checklist of all supporting documentation for the claim.



Ham-Cheddar Cheese Ball

About Our Office



On March 22, 1945 the SC General Assembly adopted a bill creating a VA office in each of the state's 46 counties. The Lexington

County VA Director is appointed by the Lexington County delegation. This office is employed by Lexington County; not the Federal VA. The Lexington County Veterans' Affairs Office is an advocate for Veterans and their surviving dependents. We provide the assistance needed in applying for benefits from the Department of Veterans Affairs and for VA medical care. The Lexington County VA Office assists former and present members of the US Armed Forces and their dependents in preparing claims. Types of benefits include but not limited to: service connected disabilities and non-service connected pension; death pension benefits; burial; medical care; educational vocational rehabilitation; assistance, including guaranteed home loans; government life insurance and other benefits. We are not trained in Social Security or Department of Defense Benefits but can assist with some of these forms. Our office also provides off-site appointments at three of the County libraries once a month and we can provide home visits on a case by case basis.

Featured Medal:

Commendation Medals











The Commendation Medal is a mid-level United States military decoration which is presented for sustained acts of heroism or meritorious service. For valorous actions in direct contact with an enemy, but of a lesser degree than required for the award of the Bronze Star Medal, the Commendation Medal with a "V" Device or Combat "V" may be authorized for wear on the service and suspension ribbon of the medal. Each branch of the United States Armed Forces issues its own version of the Commendation Medal, with a fifth version existing for acts of joint military service performed under the Department of Defense. The Commendation Medal was originally only a service ribbon and was first awarded by the U.S. Navy and U.S. Coast Guard in 1943. An Army Commendation Ribbon followed in 1945, and in 1949, the Navy, Coast Guard, and Army Commendation ribbons were renamed the "Commendation Ribbon with Medal Pendant." By 1960, the Commendation Ribbons had been authorized as full medals and were subsequently referred to as Commendation Medals.

The Army Commendation Medal is awarded to any member of the Armed Forces of the United States other than General Officers who, while serving in any capacity with the U.S. Army after December 6, 1941, distinguished themselves by heroism, meritorious achievement or meritorious service. The medal may be awarded to a member of the Armed Forces of a friendly foreign nation who, after 1 June 1962, distinguishes themselves by an act of heroism, extraordinary achievement, or significant meritorious service which has been of mutual benefit to the friendly nation and the United States.

After the First World War, the Department of the Navy authorized the Navy Commendation Star as an attachment to the World War I Victory Medal. The star was identical to the Silver Citation Star, but not comparable, as the later recognized heroic combat actions, while the Navy Commendation Star denoted those who had been cited for meritorious achievement by the Secretary of the Navy. An independent Navy Commendation Ribbon was established in November 1943, designated as the Navy Commendation Medal in September 1960, and renamed the Navy and Marine Corps Commendation Medal in 1994, this decoration is awarded by operational commanders, requiring the signature of an admiral or general officer in the grade of O-7. This allows for interpretation of the criteria for which the medal may be awarded. For instance, in the U.S. Navy and U.S. Marine Corps, the Navy and Marine Corps Commendation Medal is considered a somewhat higher decoration reserved for Department Head level officers at the O-4 level, senior Navy CPOs and senior Marine Corps NCOs at the E-8 and E-9 level and, following a full career, as a retirement award. In contrast, the awarding of the Army Commendation Medal in the U.S. Army and the Air Force Commendation Medal in the U.S. Air Force is not limited to senior service members, and can be awarded to junior NCOs in the grade of E-6 and below and junior officers in the grade O-3 and below. The U.S. Marine Corps has always been issued the Navy's commendation medal and there is not a separate commendation medal intended only for Marines. This lack of difference was recognized in 1994 when Secretary of the Navy John Howard Dalton changed the name of the Navy Commendation Medal to the Navy and Marine Corps Commendation Medal.

The U.S. Coast Guard awards a separate Coast Guard Commendation Medal, with a ribbon similar in design to that of its Navy and Marine Corps counterpart. Initially established as the Coast Guard Commendation Ribbon in 1947, it was re-designated as the Coast Guard Commendation Medal in 1959. Criteria for its award has paralleled that of the Navy and Marine Corps.

The U.S. Air Force began issuing its own Air Force Commendation Medal in 1958 with additional awards denoted by oak leaf clusters. Prior to this time, USAF recipients received the Army Commendation Medal. It was not until 1996 that the "V" device was authorized on the Air Force Commendation Medal; prior to 1996, there was not a valor distinction in effect for the Air Force Commendation Medal.

The last of the Commendation Medals is the Joint Service Commendation Medal, which was created in 1963. This award is intended for senior service on a joint military staff and is senior in precedence to service-specific Commendation Medals. As such, it is worn above the service Commendation Medals on a military uniform. As a joint award, multiple awards are denoted with an oak leaf cluster regardless of service.
