Specifically, Saxon Mortgage, Inc. is hereby requested to appear before the said Court at the date, time, and place aforesaid and then and there submit to examination by Plaintiff and truly testify and answer concerning the current status of any mortgage account in the name of Junohn Dewitt and Tracy Dewitt, Jr. related to 137 Tea Olive Avenue, including current balances due. Alternatively, Saxon Mortgage, Inc. may submit, through its counsel, an affidavit attesting to the current status of the account in question and the total balance due as of some date no more than thirty (30) days before the hearing required herein.

AND IT IS FURTHER ORDERED that at said time and place Junohn Dewitt and Tracy Dewitt, Jr. and Saxon Mortgage, Inc. herein shall be required to **SHOW CAUSE** why the subject property should not be sold at the time and date described above.
