Hood, EMS Coordinator, responded \$5.674 million in revenues were anticipated for the upcoming year. The Committee requested EMS staff to provide information on the difference between the estimated and actual revenue for EMS. Chief Hood reported on the rising cost of health supplies used by EMS and concerns about the health supplies account. He responded that the ambulance transportation fee for a county resident is \$496 and \$551 for a non-county resident, this includes CPI which reflects a three percent increase. Chief Hood indicated that EMS will be utilizing an EMS truck from the twelve-hour day services and use it as a twenty-four hour truck instead of purchasing a new vehicle.
