The Special Election for the Town of Irmo will be held on Tuesday, June 3, 2025. Any person wishing to vote in the Town of Irmo Special Election who lives in the municipality must be registered in person by Friday, May 2, 2025 by 5:00 p.m. Voter registration via online application must be received no later than Sunday, May 4, 2025, at 11:59 pm. Voter registration by mail forms will be accepted if postmarked no later than Monday 5, 2025.

The Early Voting period for this Election begins on Monday, May 19, 2025 and ends on Friday, May 30, 2025. (excluding holidays, Saturdays and Sundays) The following early voting center will be open during the early voting period from 8:30 a.m. until 5:00 p.m., Monday through Friday.
