## NOTES

- Paper Shred opportunities are hosted by County partner, Keep the Midlands Beautiful (KMB).
  - There is a limit of 5 copy boxes or 5 copy-box sized bags (13-gallons) per resident
- **ELECTRONICS ARE ONLY ACCEPTED WHERE SPECIFICALLY LISTED**
  - One item can include all computer parts.
    - Example: Monitor, Modem, Mouse, keyboard= 1 bundle
  - Residents are able to bring 5 Electronics to the Edmund Landfill or Republic Services locations:
    - The Edmund Landfill is located at 429 Landfill Lane, Lexington, SC 29073
      - (Mon-Sat 7:00AM-4:30PM)
    - The Republic Services location is open **ONLY** at listed drop-off dates and times and, is not open daily. Leaving items at the site is illegal dumping and punishable by law.
- **Oxygen tanks, helium tanks, propane tanks and camping fuel tanks are only accepted at the Edmund Landfill located at: 429 Landfill Lane, Lexington, SC 29073**
