# WHAT IS THE POST- 9/11 GI BILL?

The Post- 9/11 G I Bill provides financial support for education and housing to individuals with at least 90 days of aggregate service on or after September 11, 2001, or individuals discharged with a service-connected disability after 30 days. Applicants must have received an honorable discharge to be eligible for the Post-9/11 GI Bill

The Post-9/11 GI Bill will become effective for training on or after August 1, 2009. The amount of support that an individual may qualify for depends on where they live and what type of degree they pursue.

# What does the Post- 9/11 GI Bill cover?

You may receive benefits for any approved program offered by a school in the United States that is authorized to grant an associate (or higher) degree. Visit our website at

www.GIBILL.va.gov/GI Bill Info/programs.htm to verify that the program at your school, or the program at the school you would like to attend. is approved. You may also receive benefits for tutorial assistance or up to \$2,000 for the reimbursement of one licensing or certification test.

If you transferred to the Post-9/11 GI Bill from the Montgomery GI Bill – Active Duty, Montgomery GI Bill - Selected Reserves, or the Reserve Education Assistance Program, you may also receive Post-9/11 GI Bill benefits for flight training. apprenticeship or on-the-job training programs, and correspondence courses.

performing as well-trained teams in defense of Americans and their allies in times of combat as well as peace, military working dogs and their handlers have served in our armed forces since World War II; and

WHEREAS, military working dogs and their handlers undergo extensive basic and specialized training to prepare for their assignments, which have included sentry, scout, messenger, tracker, and mine and tunnel duty, and to help reduce the casualty rate during combat, with an estimated 10,000 American soldiers' lives saved during Vietnam alone; and

WHEREAS, military working dog teams remain an active part of our country's armed forces, helping protect our troops overseas and our bases at home, including Charleston Air Force Base, Fort Jackson, Marine Corps Air Station Beaufort, Naval Weapons Station Charleston, and Shaw Air Force

#### SERVICE HONORS VETERANS OF LONG-FORGOTTEN WAR

"Someone should do it. I'm just really vehement that veterans be remembered," he said. Encouraged by the turnout, he said he hopes to make it an annual event. The service marked the anniversary of two major battles of the war, both on Aug. 20, 1847. Local historian and author of the book "South Carolina in the Mexican War," Jack Meyer, who also spoke at the event, said most people only have a vague idea about the war because it has been overshadowed by the Civil War. "But it's important to know because it led to the secession crisis of 1849-52," Meyer said.

As he explained, the United States' acquisition of more than 500,000 square miles of territory as a result of the conflict caused an imbalance in the number of free and slave states. "It destabilized things. By gaining territory, we

gained political problems. So while it was not the cause of the Civil War, it was certainly one of the causes," Meyer said. Columbia residents Carter and Barbara Ellis said the event was a "real eye-opener," especially since Carter's great-great-great uncle William E. Watson served in the Palmetto Regiment.

After thanking Robison for organizing the event, Ellis produced a silver officer's coin Walker had been awarded

for his service to the country. Ellis said it felt good to know his ancestor was still being honored, if only in some small way. "I think it's important to remember them," he said. "This war had more of an effect than people realize."



## THE MEXICAN WAR 1846-48

- Most historians agree the stage was set for war after the United States annexed Texas in 1845. The concept of "Manifest Destiny" in which the United States actively expanded its holdings also fanned the flames of conflict.
- A little more than 100,000 U.S. soldiers fought in the war with about 13,000 casualties. Only about 2,000 soldiers were killed in battle; most died from disease or illness.
- An estimated 30,000-40,000 soldiers fought for Mexico. There is no official total for the number of Mexican casualties because the Mexican government did not keep good records.
- In the end, the United States acquired more than 500,000 square miles of land from Texas to California, what now is known as the American Southwest.

#### **SOUTH CAROLINA'S ROLE:**

More than 1,000 S.C. soldiers fought in the war in the Palmetto Regiment. Of that number, more than 400 died, many from disease.

• Gov. Pierce Mason Butler was commissioned to lead the regiment. Butler died at the Battle of Churubusco on Aug. 20, 1847.
